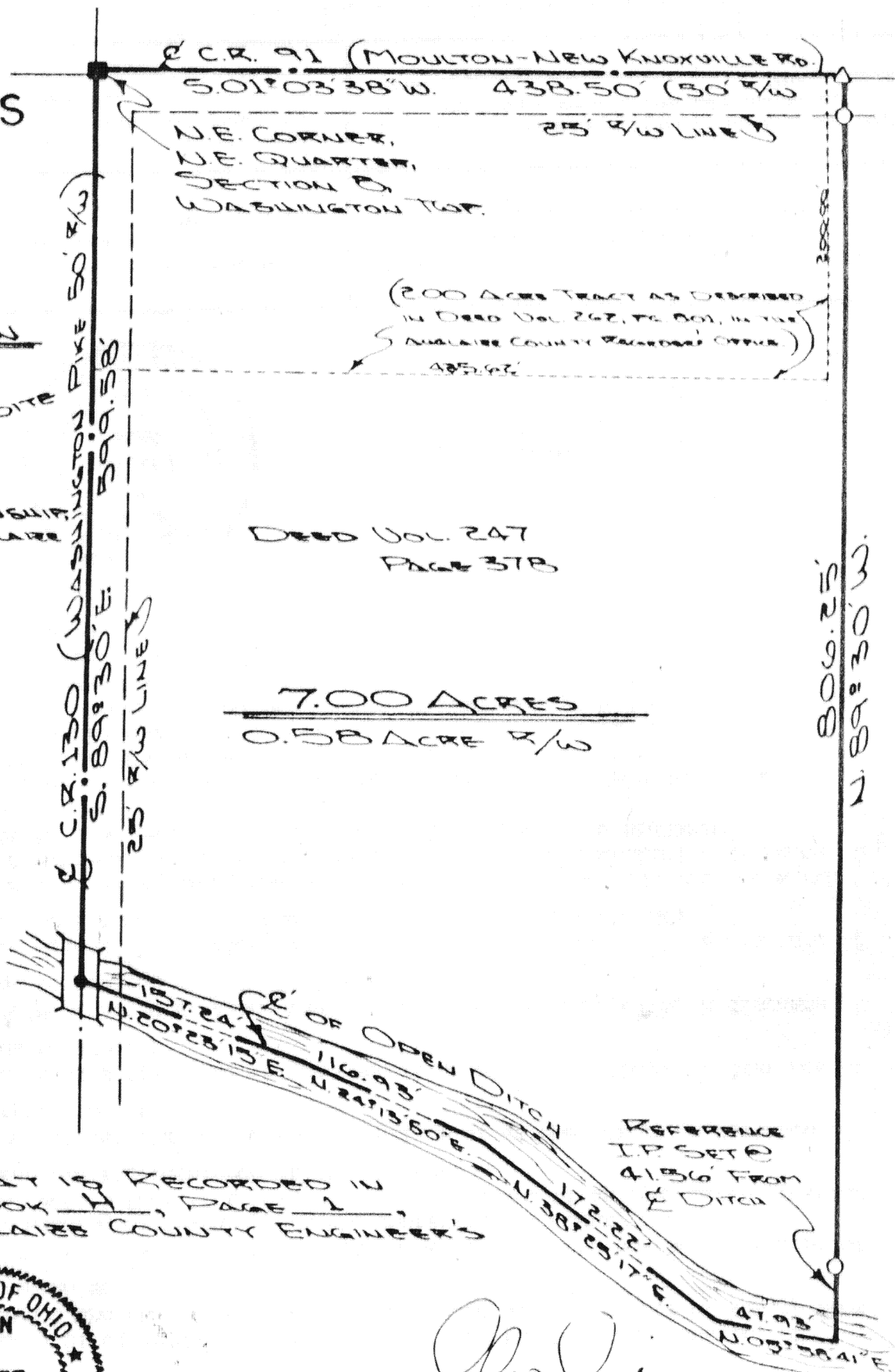

SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Northeast Quarter of the Northeast Quarter of Section 8, Town 6 South, Range 5 East, Washington Township, Auglaize County, Ohio, and is more particularly described as follows:

The PLACE OF BEGINNING is at a monument box at the Northeast corner of the Northeast Quarter of Section 8, Washington Township and in the intersection of County Road 130 (Washington Pike) and County Road 91 (Moulton - New Knoxville Road);

thence S.01°03'38"W. along the East line of the Northeast Quarter of said Section 8 and the centerline of County Road 91, a distance of 438.50 feet to a R.R. spike set;

thence N.89°30'W., parallel to the North line of the Northeast Quarter of Section 8, Washington Township and the centerline of County Road 130, a distance of 806.25 feet to a point in the centerline of an open ditch, passing thru an iron pin for reference at 764.69 feet;

thence N.05°58'41"E. along the centerline of an open ditch, a distance of 47.93 feet to a point;

thence N.38°25'17"E. along the centerline of an open ditch, a distance of 172.22 feet to a point;

thence N.24°13'50"E. along the centerline of an open ditch, a distance of 116.93 feet to a point;

thence N.20°23'15"E. along the centerline of an open ditch, a distance of 157.24 feet to a P.K. nail in the centerline of County Road 130;

thence S.89°30'E. along the centerline of County Road 130 and the North line of the Northeast Quarter of Section 8, Washington Township, a distance of 599.58 feet to a monument box, which was the true PLACE OF BEGINNING.

Containing in all 7.00 acres of which 0.58 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 247, page 378.
