






# LOCATION PLAN SECTION 34

The following described tract of land is part of the Southwest Fractional Quarter of Fractional Section 34, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio, and is more particularly described as follows: Scale: \_\_\_\_\_

Commencing at a R.R. spike in the intersection of the West line of the Northeast Fraction, Southwest Fractional Quarter of Section 34, Moulton Township, said line also being the Wapakoneta Reservation line (centerline of Bay Road), and the centerline of County Road 33-A, said spike being the PLACE OF BEGINNING; thence N.00°32'19"E. along the West line of the Northeast Fraction, Southwest Fractional Quarter Section 34 and the centerline of Bay Road, a distance of 614.54 feet to a R.R. spike;

thence N.80°48'08"E. on a line parallel to the centerline of County Road 33-A, a distance of 1,281.84 feet to an iron pin set, passing thru an iron pin set at 93.32 feet in the East right-of-way line of Bay Road;

thence S.00°35'15"W. a distance of 273.06 feet to an iron pipe found;

thence S.80°38'01"W. a distance of 300.00 feet to an iron pipe found;

thence S.80°36'52"W. a distance of 344.75 feet to an iron pipe found;

thence S.09°07'20"E. a distance of 87.34 feet to an iron pipe found;

thence S.80°42'W. a distance of 169.46 feet to an iron pin found;

thence S.80°50'45"W. a distance of 263.58 feet to a steel fence post found;

thence S.80°51'30"W. a distance of 99.89 feet to a steel fence post found;

thence S.04°53'52"E. a distance of 207.83 feet to a point;

thence S.80°48'08"W. on a line parallel to the centerline of County Road 33-A, a distance of 1.34 feet to a concrete monument found;

thence S.09°11'52"E. a distance of 40.00 feet to a P.K. nail set in the centerline of County Road 33-A;

thence S.89°27'41"E. along the centerline of a 50.00 foot wide easement, a distance of 110.62 feet to a point;

thence N.04°31'03"E. along the centerline of a 50.00 foot wide easement, a distance of 96.78 feet to a point in the North property line of a 10.00 acre tract and there to terminate.


