



SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Southwest Quarter of Section 30, Town Five (5) South, Range Six (5) East, Duchouquet Township, Auglaize County, Ohio, and is more particularly described as follows;

Commencing at the intersection of the west right-of-way line of Hamilton Drive and the North Line of Lot No. 4, Hammel Estate;  
thence with an assumed bearing of S. 00°-00'-00" E. along the west right-of-way line of Hamilton Drive for a distance of 997.00 feet to an iron pin and the PLACE OF BEGINNING;  
thence continuing along the west right-of-way line of Hamilton Drive with a bearing of S. 00°-00'-00" E. for a distance of 85.00 feet to an iron pin;  
thence with a bearing of N. 89°-15'-46" W. for a distance of 160.00 feet to an iron pin;  
thence with a bearing of N. 00°-00'-00" W. for a distance of 85.00 feet to an iron pin;  
thence with a bearing of S. 89°-15'-46" E. for a distance of 160.00 feet to an iron pin, said iron pin being the true PLACE OF BEGINNING.

The above described tract of land contains 13,600 square feet, or 0.312 Acre. This tract of land is subject to all legal easements, restrictions, or reservations, if any, on said premises. Previous Deed Reference; Deed Book 207, Page 555, located in the Auglaize County Recorder's Office.
