SURVEYOR'S DESCRIPTION FOR 2.83 ACRE TRACT

thence S.01°00'W., parallel with the West line of the Southwest Quarter of Section 32, Moulton Township, a distance of 264.00 feet to an iron pin;

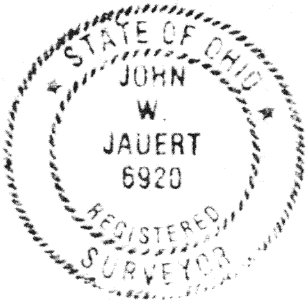
thence S.89°38'W. a distance of 345.67 feet to an iron pin;

thence S.01°00'W., parallel with the West line of the Southwest Quarter of Section 32, Moulton Township, a distance of 162.00 feet to an iron pin;


