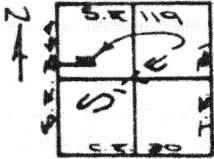


LOCATION PLAN

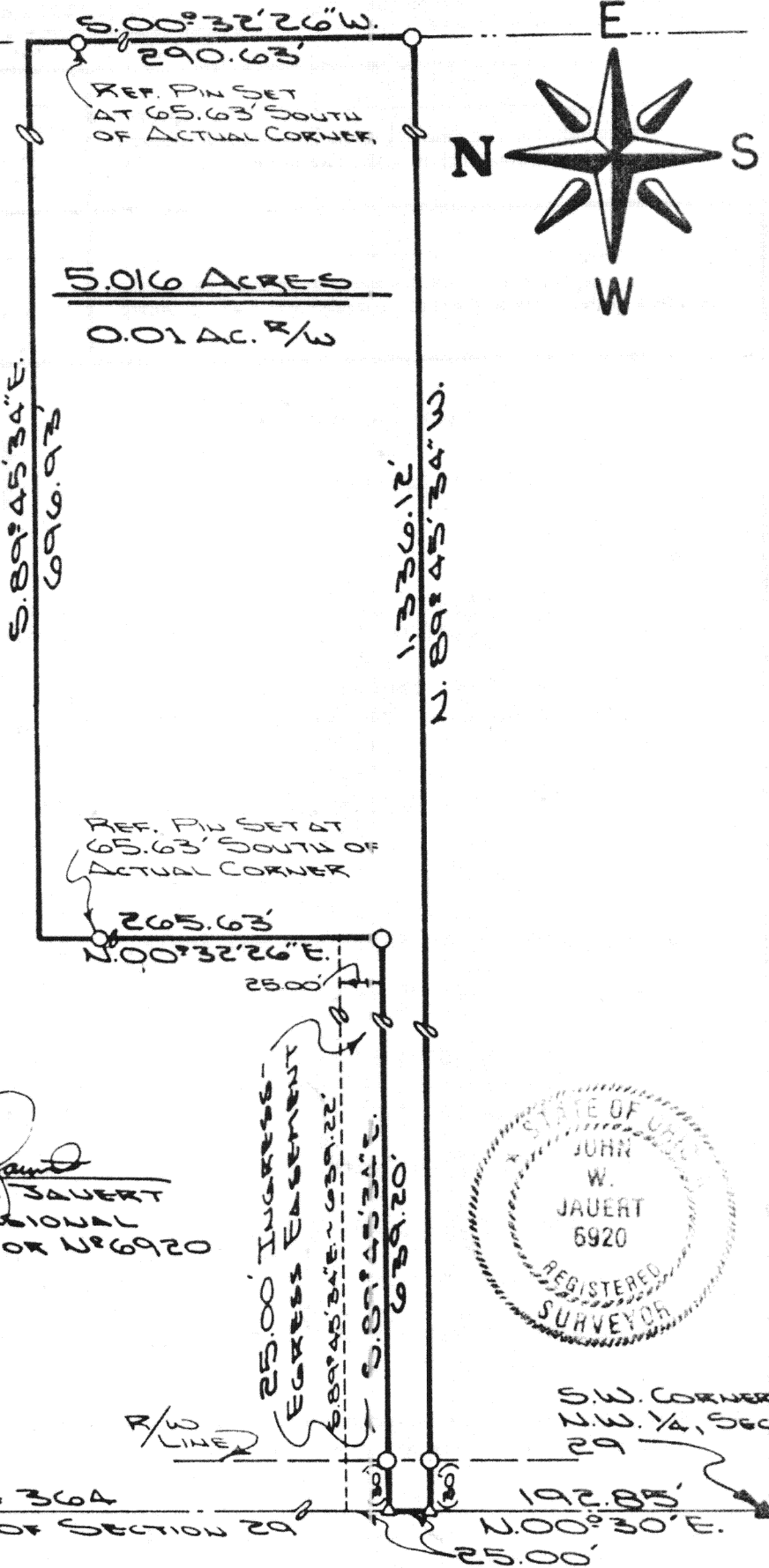

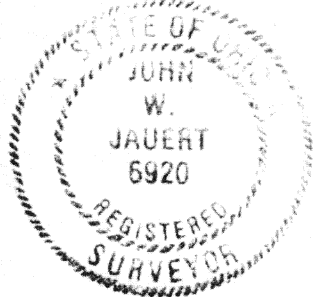

SURVEYOR'S DESCRIPTION



The following described tract of land is part of the Southwest Quarter of the Northwest Quarter of Section 29, Town 7 South, Range 4 East, Jackson Township, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at a spike over the stone at the Southwest corner of the Northwest Quarter of Section 29, Jackson Township;

thence N.00°30'E. along the centerline of State Route 364 and the West line of the Southwest Quarter of the Northwest Quarter of Section 29, Jackson Township, a distance of 192.85 feet to a P.K. nail and the PLACE OF BEGINNING;

thence continuing N.00°30'E. along the centerline of State Route 364 and the West line of the Southwest Quarter of the Northwest Quarter of said Section, a distance of 25.00 feet to a P.K. nail;

thence S.89°45'34"E. a distance of 639.20 feet to an iron pin, passing thru an iron pin at 30.00 feet in the East right-of-way line of State Route 364;

thence N.00°32'26"E. a distance of 265.63 feet to a point;

thence S.89°45'34"E. a distance of 696.93 feet to a point;

thence S.00°32'26"W. a distance of 290.63 feet to an iron pin;

thence N.89°45'34"W. a distance of 1336.12 feet to a P.K. nail in the centerline of State Route 364, passing thru an iron pin at 1,306.12 feet in the East right-of-way line of State Route 364, said P.K. nail was the true PLACE OF BEGINNING for the above described tract of land.

Containing in all 5.016 acres of land of which 0.01 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 237, page 218. thence N.00°30'E. along the centerline of State Route 364 and the West line of the Southwest Quarter of the Northwest Quarter of Section 29, Jackson Township, a distance of 217.85 feet to a P.K. nail and the PLACE OF BEGINNING;

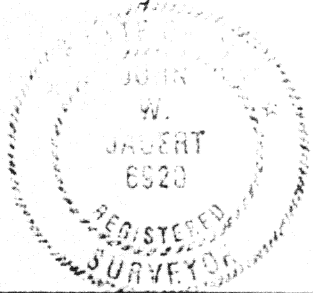
thence continuing N.00°30'E., a distance of 25.00 feet to a point;

thence S.89°45'34"E. a distance of 639.22 feet to a point;

thence S.00°32'26"W. a distance of 25.00 feet to an iron pin;

thence N.89°45'34"W. a distance of 639.20 feet to a P.K. nail, which was the true PLACE OF BEGINNING.
