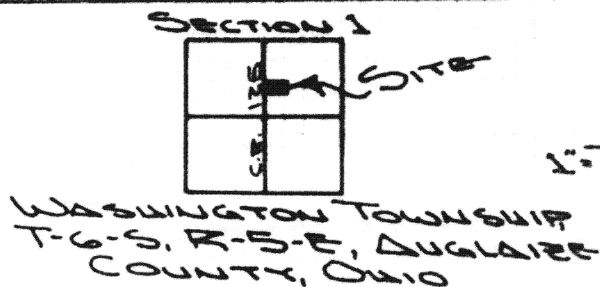


LOCATION PLAN



LEGEND

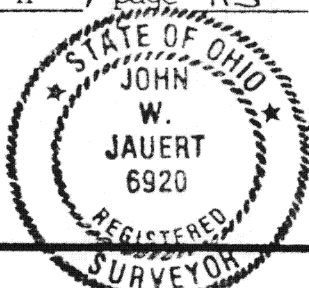
- IRON PIN SET

SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Northeast Fractional Quarter of Section 1, Town 6 South, Range 5 East, Washington Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at the Southwest corner of the Northeast Quarter of Section 1, Washington Township;
 thence with an assumed bearing of N.00°30'W. along the centerline of County Road 125 (Kohler Road), a distance of 698.22 feet to a R.R. Spike and the PLACE OF BEGINNING for the tract of land herein described;
 thence continuing N.00°30'W. along the centerline of County Road 125, a distance of 230.00 feet to a R.R. Spike;
 thence N.89°30'E. a distance of 254.26 feet to an iron pin, passing thru an iron pin at 25.00 feet in the East right-of-way line of County Road 125;
 thence S.00°30'E., parallel to the centerline of County Road 125, a distance of 230.00 feet to an iron pin;
 thence S.89°30'W. a distance of 254.26 feet to a R.R. Spike in the centerline of County Road 125, passing thru an iron pin at 229.26 feet in the East right-of-way line of County Road 125, said R.R. Spike was the true PLACE OF BEGINNING.

Containing in all 1.342 acres of which 0.132 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions, and reservations of record or in use on said premises. Previous deed reference: Volume OR53, page 9. This survey is recorded in Survey Book "H", page 115, in the Auglaize County Engineer's Office.
