

The following described tract of land is part of the Southwest Quarter of the Southeast Quarter of Section 27, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Southeast Quarter of Section 27, Pusheta Township;

thence with an assumed bearing of S.89°50'20"W. along the centerline of Township Road 90 (Southland Road) and the South line of the Southeast Quarter of Section 27, Pusheta Township, a distance of 1,856.55 feet to a R.R. spike and the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.89°50'20"W. along the centerline of Township Road 90 and the South line of the Southeast Quarter of Section 27, Pusheta Township, a distance of 190.00 feet to a R.R. spike;

thence N.00°16'53"E. a distance of 1,072.34 feet to an iron pin, passing thru an iron pin for reference at 25.00 feet;

thence N.89°50'20"E., parallel to the South line of the Southeast Quarter of said Section and the centerline of Township Road 90, a distance of 714.64 feet to an iron pin;

thence S.00°16'53"W. a distance of 109.84 feet to an iron pin;

thence S.89°50'20"W., parallel to the South line of the Southeast Quarter of Section 27, Pusheta Township and the centerline of Township Road 90, a distance of 524.64 feet to an iron pin;

thence S.00°16'53"W. a distance of 962.50 feet to a R.R. spike in the South line of the Southeast Quarter of said Section and in the centerline of T.R. 90, passing thru an iron pin for reference at 937.50 feet, said R.R. spike was the true PLACE OF BEGINNING.

Containing in all 6.000 acres of which 0.087 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 249, page 868.
