



SURVEYOR'S DESCRIPTION

Scale:

The following described tract of land is part of the East half of the Southwest Quarter of Section 9, Town 5 South, Range 7 East, Union Township, Auglaize County, Ohio and being more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Southwest Quarter of Section 9, Union Township;

thence with an assumed bearing of S.89°29'23"W. along the centerline of County Road 180 (Fairmount Road) and the South line of the Southwest Quarter of said Section, a distance of 1,044.33 feet to a R.R. spike set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.89°29'23"W. along the centerline of County Road 180 and the South line of the Southwest Quarter of Section 9, Union Township, a distance of 20.00 feet to a R.R. spike set;

thence N.01°18'37"W. a distance of 1,343.73 feet to an iron pin set;

thence S.89°29'23"W., parallel to the centerline of County Road 180 and the South line of said Section, a distance of 164.83 feet to an iron pin set;

thence N.00°59'38"E. a distance of 401.71 feet to an iron pin set;

thence S.89°42'22"E. a distance of 541.07 feet to an iron pin set;

thence S.00°44'20"W. a distance of 394.07 feet to an iron pin set;

thence S.89°29'23"W., parallel to the centerline of County Road 180 and the South line of the Southwest Quarter of Section 9, Union Township, a distance of 358.14 feet to an iron pin set;

thence S.01°18'37"E. a distance of 1,343.73 feet to a R.R. spike, passing thru an iron pin at 1,318.73 feet in the North right-of-way line of County Road 180, said R.R. spike was the true PLACE OF BEGINNING.

Containing in all 5.567 acres of which 0.011 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
