

The following described tract of land is part of the Southeast Quarter of Section Ten (10), Town Six (6) South, Range Four (4) East, St. Mary's Township, Auglaize County, Ohio, and is more particularly described as follows;

Commencing at a 1" Iron Bar located at the Northeast Corner of Tract #4 of the South Park Subdivision of St. Mary's, Ohio, as Recorded in Plat Book "C" Page 9, of the Auglaize County Recorder's Office;

thence with a bearing of N. 70°-42' E. along the South right-of-way line of South Park Drive a distance of 68.09 feet to an iron pin;

thence continuing with a bearing of N. 70°-42' E. along the South right-of-way line of South Park Drive a distance of 130.28 feet to an iron pin and the PLACE OF BEGINNING;

thence continuing with a bearing of N. 70°-42' E. along the South right-of-way line of South Park Drive a distance of 76.89 feet to an iron pin;

thence with a bearing of N. 84°-29' E. along the South right-of-way line of South Park Drive a distance of 92.83 feet to an iron pin;

thence with a bearing of S. 21°-53' E. along the West right-of-way line of State Route #66 a distance of 352.86 feet to an iron pin;

thence with a bearing of S. 70°-42' W. and parallel with the centerline of South Park Drive a distance of 182.36 feet to an iron pin;

thence with a bearing of N. $19^{\circ}-23^{\circ}-25^{\circ}$ W. a distance of 374.62 feet to an iron pin and the PLACE OF BEGINNING.

Containing in all, 1.476 Acres of land subject to all legal easements, reservations, or restrictions, if any, upon said premises. Bearings for this . Survey were based upon a previous Survey performed by Gordon L. Geeslin, P.S. 5372, on the original 2.526 Acre tract of land which had contained the above described 1.476 Acres, now remaining 1.05 Acres.
