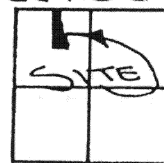


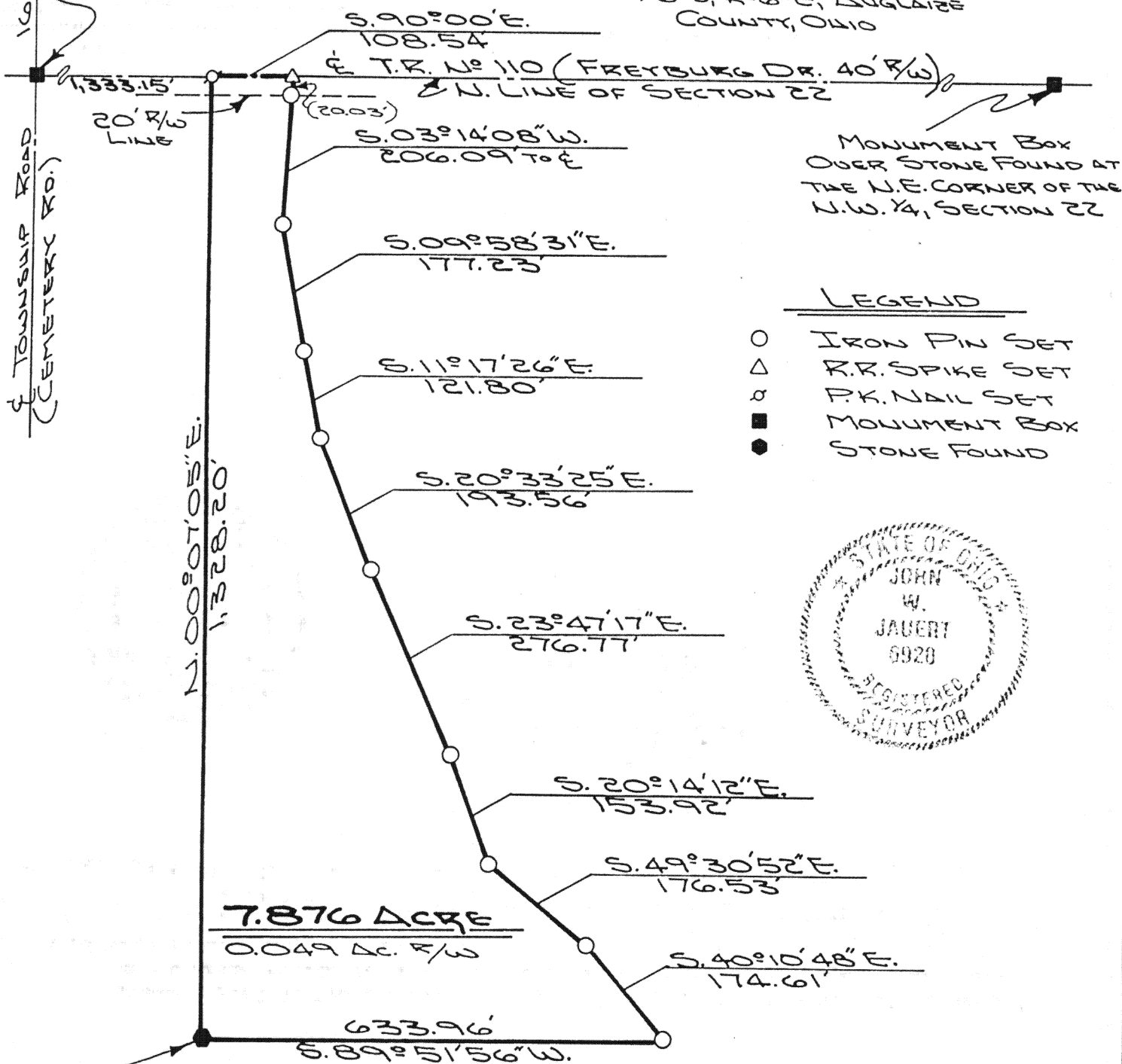
LOCATION PLAN SECTION 22

CORNER, N.W. 1/4, SEC. 22.

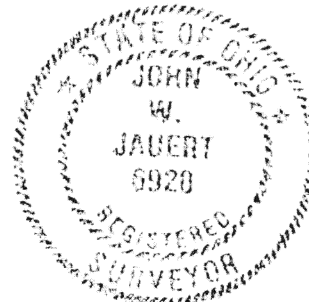

SURVEYOR'S DESCRIPTION FOR 7.876 ACRE

The following described tract of land is part of the Northeast Quarter of the Northwest Quarter of Section 22, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box over the stone at the Northwest corner of the Northwest Quarter of Section 22, Pusheta Township and in the intersection of Township Road 161 (Cemetery Road) and Township Road 110 (Freyburg Drive);

thence with an assumed bearing of S.90°00'E. along the centerline of Township Road 110 and the North line of the Northwest Quarter of Section 22, Pusheta Township, a distance of 1,333.15 feet to a P.K. nail which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.90°00'E. along said line, a distance of 108.54 feet to a Railroad spike set;

thence S.03°14'08"W. a distance of 206.09 feet to an iron pin set, passing thru an iron pin set for reference at 20.03 feet in the South right-of-way line of Township Road 110;

thence S.09°58'31"E. a distance of 177.23 feet to an iron pin set;

thence S.11°17'26"E. a distance of 121.80 feet to an iron pin set;

thence S.20°33'25"E. a distance of 193.56 feet to an iron pin set;

thence S.23°47'17"E. a distance of 276.77 feet to an iron pin set;

thence S.20°14'12"E. a distance of 153.92 feet to an iron pin set;

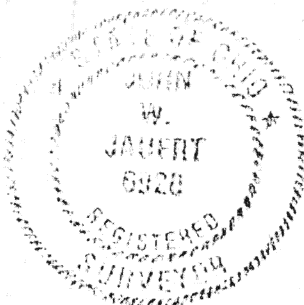
thence S.49°30'52"E. a distance of 176.53 feet to an iron pin set;

thence S.40°10'48"E. a distance of 174.61 feet to an iron pin set;


thence S.89°51'56"W. a distance of 633.96 feet to a stone found;

thence N.00°07'05"E. a distance of 1,328.20 feet to a P.K. nail in the centerline of Township Road 110, said P.K. nail was the true PLACE OF BEGINNING.
