

CORRECTIVE SURVEYOR'S DESCRIPTION



The following described tract of land is part of the Northeast Quarter of Section 33, Town 4 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio, and is more particularly described as follows:

The PLACE OF BEGINNING is at the Section Stone at the Northwest corner of the Northeast Quarter of Section 33, Duchouquet Township;

thence S89°04'04"E along the North line of the Northeast Quarter of Section 33, Duchouquet Township and the Auglaize-Allen County Line, a distance of 2,648.17 feet to a monument box in the centerline of Township Road 161 (Hauss Road), said monument box being the Northeast corner of the Northeast Quarter of Section 33, Duchouquet Township;

thence S01°04'30"W along the centerlinr of Township Road 161 (Hauss Road), a distance of 456.32 feet to a R.R. spike;

thence N88°25'30"W a distance of 264.00 feet to a point;

thence S01°04'30"W, parallel to the centerline of Township Road 161, a distance of 165.00 feet to a point;

thence N88°25'30"W a distance of 353.21 feet to an iron pin;

thence S01°04'04"W a distance of 651.38feet to a R.R. spike in the centerline of County Road 208 (National Road);

thence S90°00'W along the centerline of County Road 208, a distance of 1,703.50 feet to a R.R. spike;

thence NO1°10'E a distance of 264.00 feet to an iron pin;

thence S90°00'W on a line parallel to the centerline of County Road 208, a distance of 165.00 feet to an iron pin;

thence NO1°10'E along the North - South half Section line of Section 33, Duchouquet Township, a distance of 1,034.87 feet to a Section Stone at the Northwest corner of the Northeast Quarter of Section 33, Duchouquet Township, said Section Stone was the true PLACE OF BEGINNING.

Containing in all 65.573 acres of which 1.186 acres has been dedicated for highway purposes. The above tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
