



## SURVEYOR'S DESCRIPTION

The following described tract of land is part of the South half of Section 4, Town 7 South, Range 4 East, German Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a monument box at the Southwest corner of the Southeast Quarter of Section 4, German Township and in the centerline of County Road 70 (Lock Two Road);

thence S.89°33'30"W. along the centerline of County Road 70 and the South line of the Southwest Quarter of Section 4, German Township, a distance of 12.00 feet to a R.R. spike set;

thence N.01°06'55"W., parallel with the East line of the Southwest Quarter of Section 4, German Township, a distance of 1,334.67 feet to an iron pin set;

thence N.42°25'11"E. a distance of 17.42 feet to an iron pin set in the East line of the Southwest Quarter of Section 4, German Township;

thence N.89°48'20"E. a distance of 478.96 feet to an iron pin set;

thence N.00°11'40"W. a distance of 218.00 feet to an iron pin set;

thence N.89°48'20"E. a distance of 265.00 feet to an iron pin set;

thence S.00°11'40"E. a distance of 234.15 feet to an iron pin set;

thence S.89°17'27"W. a distance of 723.42 feet to a wood corner post;

thence S.42°20'40"W. a distance of 11.37 feet to a wood corner post;

thence S.01°05'55"E. a distance of 1,316.32 feet to a R.R. spike set in the centerline of County Road 70;

thence S.89°27'30"W. along the centerline of County Road 70 and the South line of the Southeast Quarter of Section 4, German Township, a distance of 12.00 feet to a monument box at the Southwest corner of the Southeast Quarter of Section 4, German Township, said monument box was the true PLACE OF BEGINNING.

Containing in all 2.40 acres of which 0.01 acre has been dedicated for highway purposes, 0.37 acre being in the Southwest Quarter of Section 4 and 2.03 acre being in the Southeast Quarter of Section 4, German Township. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
