



SURVEYOR'S DESCRIPTION

The following described tract of land is part of the South half of the Southeast Quarter of Section 8, Town 5 South, Range 4 East, Noble Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at an iron pin over the stone found at the Southeast corner of the Southeast Quarter of Section 8, Noble Township and in the intersection of the centerlines of Township Road 180 (Easterly Road) and State Route 116;

thence N.00°12'45"W. along the centerline of State Route 116 and the East line of the Southeast Quarter of Section 8, Noble Township, a distance of 885.10 feet to a R.R. spike found which is the PLACE OF BEGINNING for the tract of land herein described;

thence S.89°27'15"W. a distance of 1,249.32 feet to a point in the centerline of an existing creek;

thence N.13°56'38"W. along the centerline of the creek, a distance of 66.50 feet to a point;

thence N.39°19'19"W. along the centerline of the creek, a distance of 44.96 feet to a point;

thence N.24°41'26"W. along the centerline of the creek, a distance of 66.77 feet to a point;

thence N.39°20'33"W. along the centerline of the creek, a distance of 259.33 feet to a point;

thence N.04°31'18"E. along the centerline of the creek, a distance of 82.37 feet to a point;

thence N.89°26'43"E. a distance of 1,477.99 feet to a R.R. spike set, passing thru an iron pin set for reference at 1,447.99 feet in the West right-of-way line of State Route 116;

thence S.00°12'45"E. along the centerline of State Route 116 and the East line of the Southeast Quarter of Section 8, Noble Township, a distance of 445.07 feet to a R.R. spike which was the true PLACE OF BEGINNING.

Containing in all 14.029 acre of which 0.307 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 150, page 316. This plat is recorded in Survey Book "H", page 305, in the Auglaize County Engineer's Office. The bearing of N.00°12'45"W. for the centerline of State Route 116, was based on a previous survey by Michael L. Weadock on the parcel South of this one.
