thence S.89°25'21"E. a distance of 262.76 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet in the East right-of-way line of Township Road 161;

thence S.00°00'E., parallel with the centerline of Township Road 161 and the West line of the Southwest Quarter of Section 3, Pusheta Township, a distance of 179.44 feet to an iron pin set;


