


# LOCATION PLAN

STATE ROUTE 274

The following described tract of land is part of the West half of Section 16, Town 7 South, Range 4 East, German Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a R.R. spike at the Northeast corner of the Northwest Quarter of Section 16, German Township, and in the centerline of State Route 274;

thence Southerly along the North - South half section line a distance of 1,330.00 feet to a point being the PLACE OF BEGINNING for the tract of land herein described;

thence continuing Southerly along the North-South half section line a distance of 550.00 feet to a point;

thence with an interior angle of  $89^{\circ}30'40''$ , a distance of 30.00 feet to a point;


thence Northerly with an interior angle of  $90^{\circ}29'20''$ , along the West side of a 30.00 foot right-of-way and parallel to the North-South half section line of section 16, German Township, a distance of 550.00 feet to a point;

thence Easterly with an interior angle of  $89^{\circ}30'40''$ , a distance of 30.00 feet to a point which was the true PLACE OF BEGINNING.

Containing 0.37 acre and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 27, page 624. This plat is recorded in Survey Book "H", page 469, in the Auglaize County Engineer's Office.
