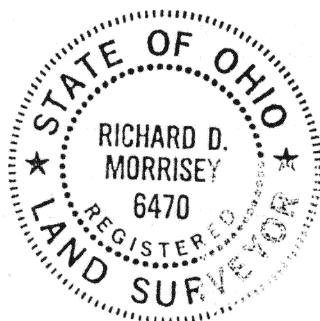


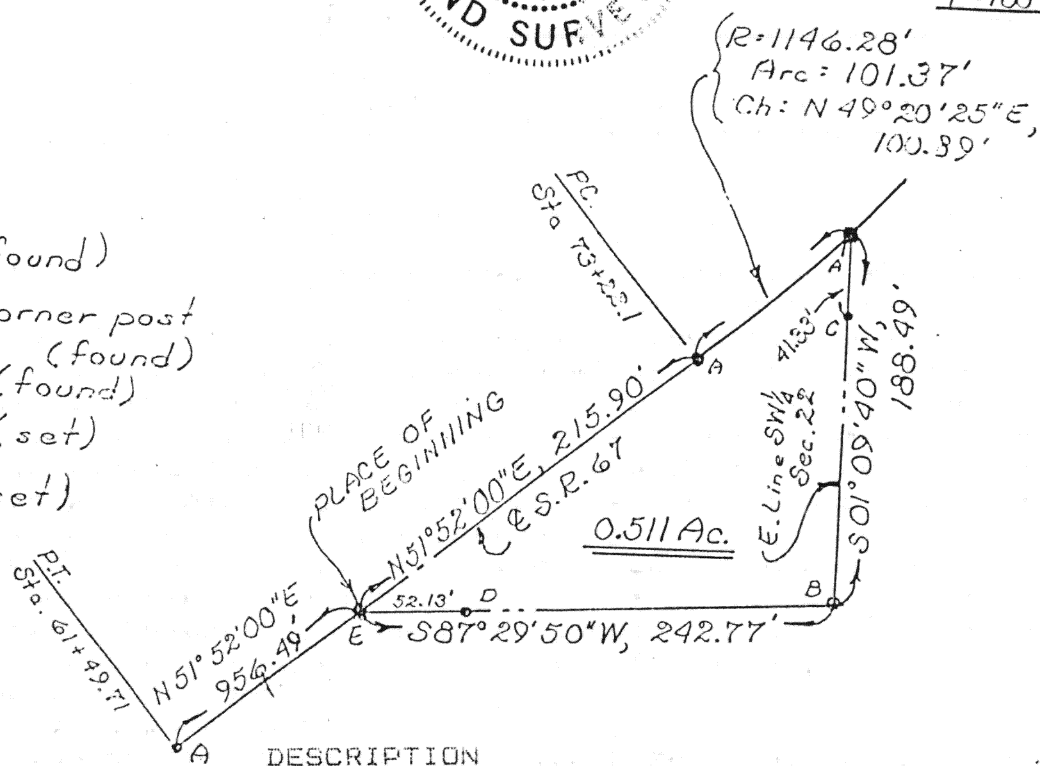
SECTION 22

DESCRIPTION

Being a parcel of land situate in the South half of Section 22, T-5-S, R-6-E, Duchouquet Township, Auglaize County, Ohio and more particularly described as follows:

Reference Bearing: South line of the Southwest quarter of Section 22 is N 89°11'10" W

Commencing at an iron pipe found at the southwest corner of the Southwest quarter of said Section 22; thence N 38°32'40" E, 1253.76 feet to a concrete monument found 30.00 feet left of Station 30+00 of the centerline of State Route 67; thence N 56°17'00" E, 854.64 feet to a PK nail found at the P.C. of a curve to the left; thence northwesterly with said curve to the left having a radius of 5729.58 feet an arc length of 240.04 feet to a PK nail found at the P.T. of said curve (chord for said curve is N 53°04'00" E, 240.03 feet); thence N 51°52'00" E with the centerline of State Route 67, 956.49 feet to a PK set and the PLACE OF BEGINNING thence continuing N 51°52'00" E with said centerline of said State Route 67, 215.90 feet to a PK nail found at the P.C. of a curve to the left; thence northeasterly with said curve to the left having a radius of 1146.28 feet an arc 101.37 feet to a PK nail found at the intersection of said centerline with the east line of the Southwest quarter of said Section 22 (chord for said curve is N 49°20'25" E, 100.89 feet); thence S 00°59'20" W with said east line of said Southwest quarter (passing through a 5/8 inch rebar found at 41.33 feet), 188.49 feet to an eight (8) inch wood post found; thence S 87°29'50" W (passing through a 5/8 inch rebar set at 190.64 feet), 242.77 feet to the PLACE OF BEGINNING containing 0.511 acres more or less and subject to all highway and other legal easements of record.
