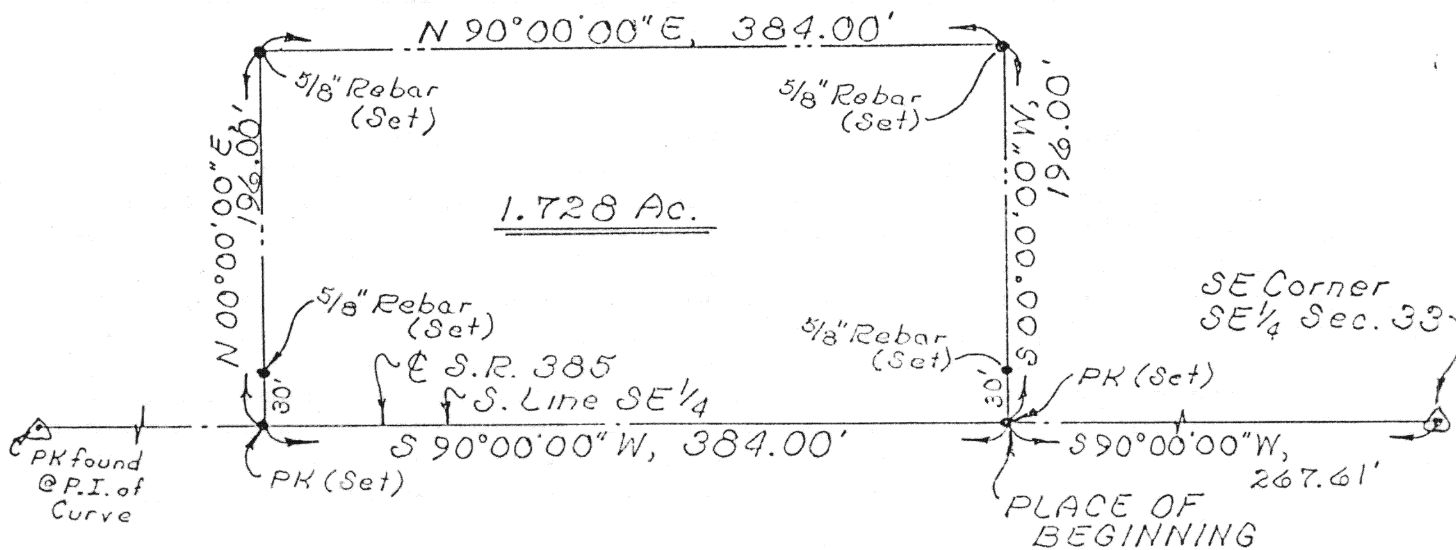
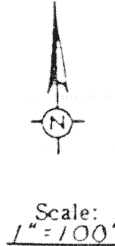


SECTION 33

#### DESCRIPTION

Being a parcel of land situate in the east half of the Southeast quarter of Section 33, T-5-S, R-8-E, Goshen Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a rebar found at the southeast corner of said Southeast quarter of said Section 33; thence S 90°00'00" W (assumed bearing) with the south line of said Southeast quarter (also the centerline of State Route 385), 267.61 feet to a PK nail set and the PLACE OF BEGINNING; thence continuing S 90°00'00" W with said south line and centerline), 384.00 feet to a PK nail set; thence N 00°00'00" E (passing through a 5/8 inch rebar set at 30.00 feet), 196.00 feet to a 5/8 inch rebar set; thence N 90°00'00" E, 384.00 feet to a 5/8 inch rebar set; thence S 00°00'00" W (passing through a 5/8 inch rebar set at 166.00 feet), 196.00 feet to the PLACE OF BEGINNING containing 1.728 acres more or less and subject to all highways and other legal easements of record.
