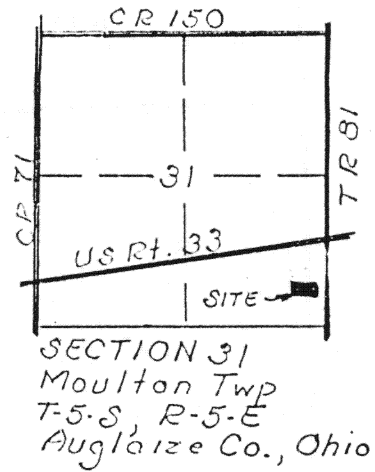
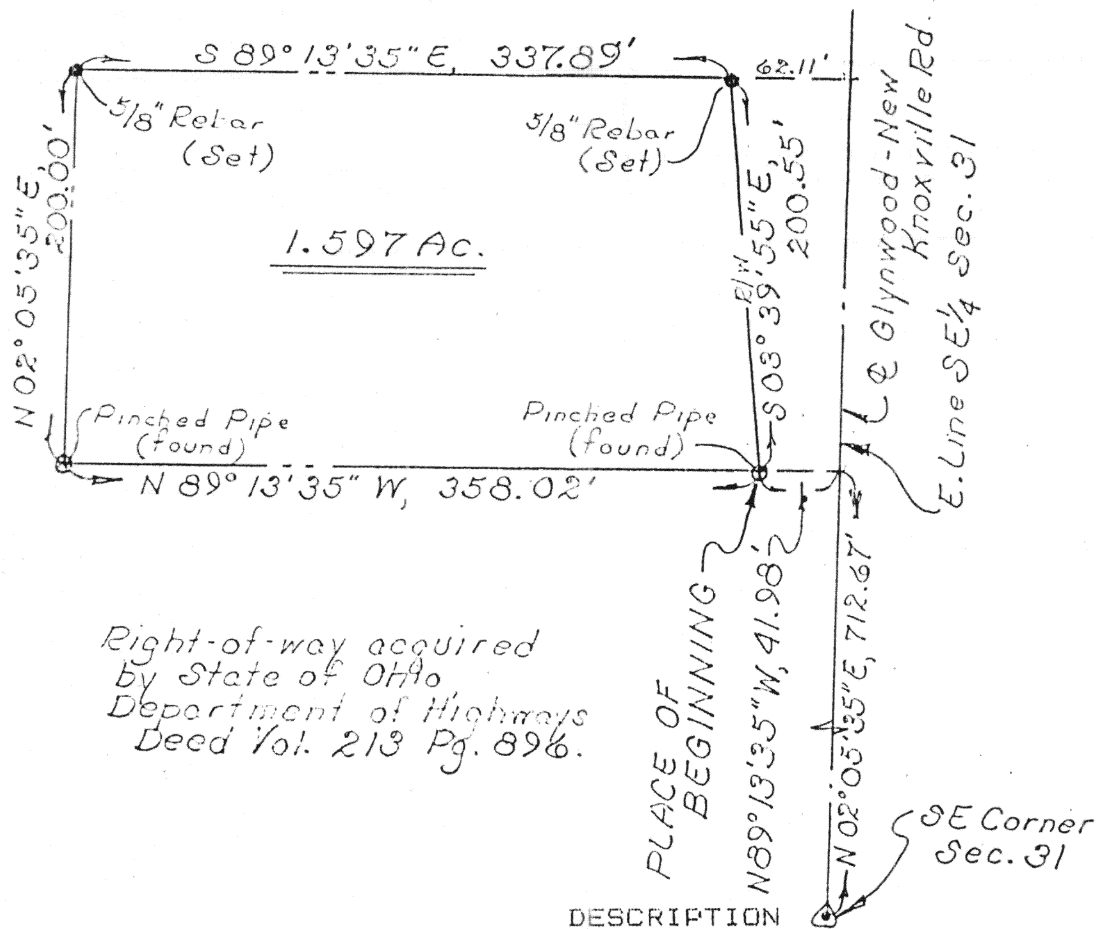

DESCRIPTION

Being a parcel of land situate in the Southeast quarter of Section 31, Moulton Township, T-5-S, R-5-E, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box found at southeast corner of said Southeast quarter of said Section 31; thence N 02°05'35" E with the east line of said Southeast quarter (also the centerline of Glynwood-New Knoxville Road), 712.67 feet to a PK nail set; thence N 89°13'55" W, 41.98 feet to a pinched pipe found on the west line of the right-of-way acquired by the State of Ohio Department of Highways in Deed Volume 213 on Page 896 through 702 and the PLACE OF BEGINNING thence continuing N 89°13'35" W, 358.02 feet to a pinched pipe found; thence N 02°05'35" E, 200.00 feet to a 5/8 inch rebar set; thence S 89°13'35" E, 337.89 feet to a 5/8 inch rebar set on west line of said right-of-way acquired by the State of Ohio Department of Highways; thence S 03°39'55" E with said west right-of-way line, 200.55 feet to the PLACE OF BEGINNING containing 1.597 acres more or less and subject to all legal easements of record.
