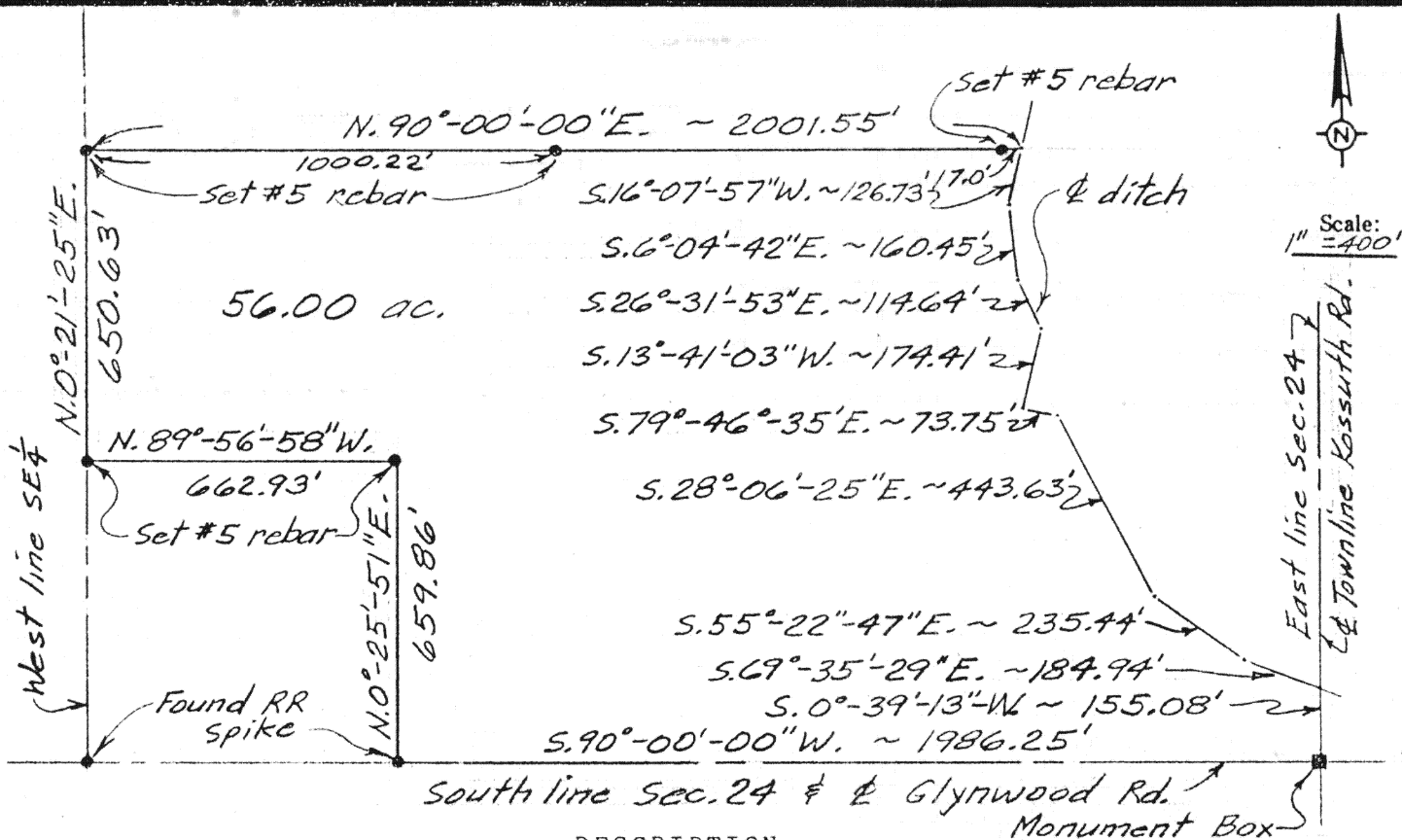




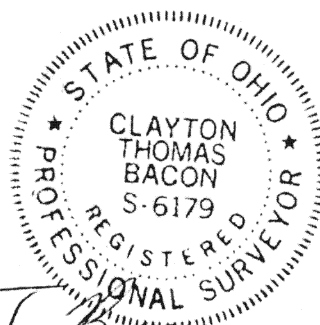
DESCRIPTION

Being a parcel of land in the SE $\frac{1}{4}$ of Section 24, Noble Township, T5S, R4E, Auglaize County, Ohio, more particularly described as follows:

Beginning at a monument box at the southeast corner of Section 24, thence the following courses;

1. S.90°-00'-00"W. (assumed bearing) on the south line of Section 24 (being also the centerline of Glynwood Rd.), 1986.25' to a found RR spike;
2. N.0°-25'-51"E., 659.86' to a set #5 rebar;
3. N.89°-56'-58"W., 662.93' to a set #5 rebar on the west line of the SE $\frac{1}{4}$;
4. N.0°-21'-25"E. on the west line of the SE $\frac{1}{4}$, 650.63' to a set #5 rebar;
5. N.90°-00'-00"E., 2001.55' to the center of a ditch, passing over a set #5 rebar at 1000.22' and at 1984.55';
6. S.16°-07'-57"W. on the ditch centerline, 126.73';
7. S.6°-04'-42"E. on the ditch centerline, 160.45';
8. S.26°-31'-53"E. on the ditch centerline 114.64';
9. S.13°-41'-03"W. on the ditch centerline, 174.41';
10. S.79°-46'-35"E. on the ditch centerline, 73.75';
11. S.28°-06'-25"E. on the ditch centerline 443.63';
12. S.55°-22'-47"E. on the ditch centerline, 235.44';
13. S.69°-35'-29"E. on the ditch centerline, 184.94' to the east line of Section 24 (being also the centerline of Townline Kossuth Rd.);
14. S.0°-39'-13"W. on the east section line, 155.08' to the POINT OF BEGINNING.

The above described parcel contains 56.00 acres, more or less, subject to all legal highways and easements of record.
