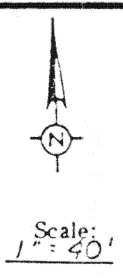
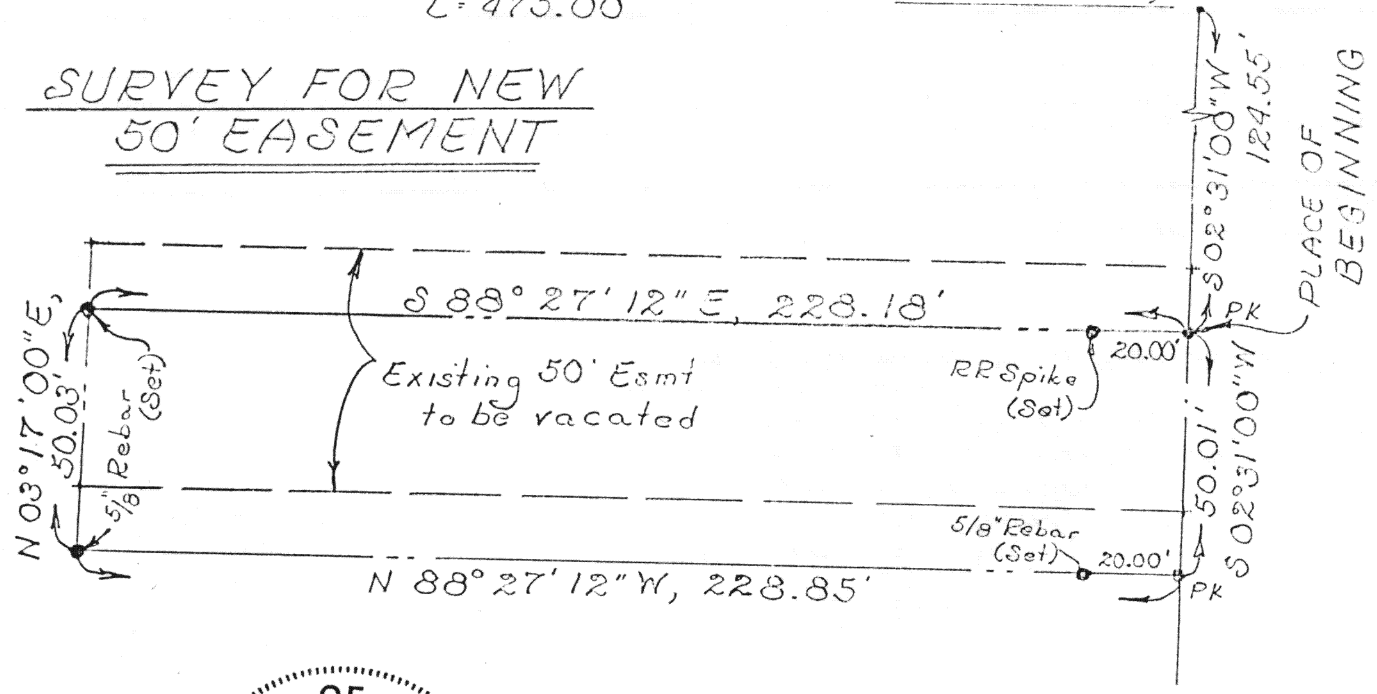

DESCRIPTION FOR  
NEW EASEMENT

Being a part of the Northeast quarter of Section 4, Pusheta Township, T-6-S, R-6-E, Auglaize Township, Ohio and more particularly described as follows:

Commencing at the intersection of the Cemetery Road and the north line of said Section 4, Pusheta Township; thence S 00° 08' 30" W with the centerline of said Cemetery Road, 219.03 feet to the P.C. of a curve to the right having a radius of 11,459.16 feet and a central angle of 2° 22' 30", an arc length of 475.00 feet to the P.T. of said curve; thence S 02° 31' 00" W continuing with said centerline of said Cemetery Road, 124.55 feet to a PK nail set and the PLACE OF BEGINNING for said easement; thence continuing S 02° 31' 00" W with said centerline, 50.01 feet to a PK nail set; thence N 88° 27' 12" W (passing through a 5/8 inch rebar set at 20.00 feet), 228.85 feet to a 5/8 inch rebar set; thence N 03° 17' 00" E, 50.03 feet to a 5/8 inch rebar set; thence S 88° 27' 12" E (passing through a railroad spike set at 208.18 feet), 228.18 feet to the PLACE OF BEGINNING containing 0.262 acre more or less and subject to all highway and other legal easements of record.
