

DESCRIPTION PARCEL NO. 1

Being a parcel of land situate in the Southwest quarter of Section 12, Pusheta Township, T-6-5, R-6-E, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box over a stone at the southwest corner of said Southwest quarter of said Section 12; thence N $\emptyset\emptyset^\circ 3\emptyset^\circ 2\emptyset^\circ$ E with the east line of said Southwest quarter (also the centerline of Brown Road, T.R.-181), 1732.60 feet to a railroad spike found; thence N $89^\circ 11^\circ 200^\circ$ E, 295.16 feet to a 5/8 inch rebar set and the PLACE OF BEGINNING; thence continuing N $89^\circ 11^\circ 200^\circ$ E, 356.36 feet to a 5/8 inch rebar set; thence N $91^\circ 31^\circ 200^\circ$ E, 260.75 feet to a 1/2 inch iron pipe found; thence S $99^\circ 11^\circ 200^\circ$ W, 390.99 feet to a 5/8 inch rebar set; thence S $90^\circ 30^\circ 200^\circ$ W, 260.61 feet to the PLACE OF BEGINNING containing 2.324 acres more or less and subject to all legal easements of record.

Being a parcel of land situate in the Southwest quarter of Section 12, Pusheta Township, T-6-S, R-6-E, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box over a stone at the southwest corner of said Southwest quarter of said Section 12; thence N ØØ°30'00" E with the east line of said Southwest quarter the centerline of Brown Road, T.R.-181), 1732.60 feet to a railroad spike found; thence N 89°11' 20" E, 295.16 feet to a 5/8 inch rebar set and the PLACE OF BEGINNING; thence continuing N 89°11'00" E, 386.36 feet to a 5/8 inch rebar set; thence S 01°31'00" W, 295.33 feet to a iron pin found; S 89°11'00" W, 381.12 feet to a 5/8 inch rebar set; thence N 00°30'00" E, 295.16 feet to the PLACE OF BEGINNING containing 2.600 acres more or less and subject to all legal easements of record. Parcel No. 2 also will receive the rights of an fifty foot easement as recorded in Official Records Volume 46 on page 494 in the Auglaize Records Office for ingress and egress to said Parcel No. 2.
