Commencing for reference at a stone found marking the northwest corner of the northwest  $\frac{1}{4}$ ; thence south 2°-50' west, on and along the centerline of Townline-Lima Road and the west line of the northwest  $\frac{1}{4}$  for a distance of 2294.35 feet to a railroad spike found; thence south  $87^{\circ}-10'$  east, for a distance of 406.00 feet to a 5/8 inch iron pin set; thence north 2°-50' east, for a distance of 121.91 feet to a 5/8 inch iron pin set for the principal point of beginning for the parcel to be conveyed by this instrument -

(1) Thence continuing north 2°-50' east, for a distance of 333.07 feet to an iron pin found -

(2) Thence south  $88^{\circ}-34'-20''$  east, for a distance of 916.10 feet to a 5/8 inch iron pin set -
