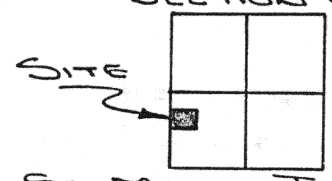
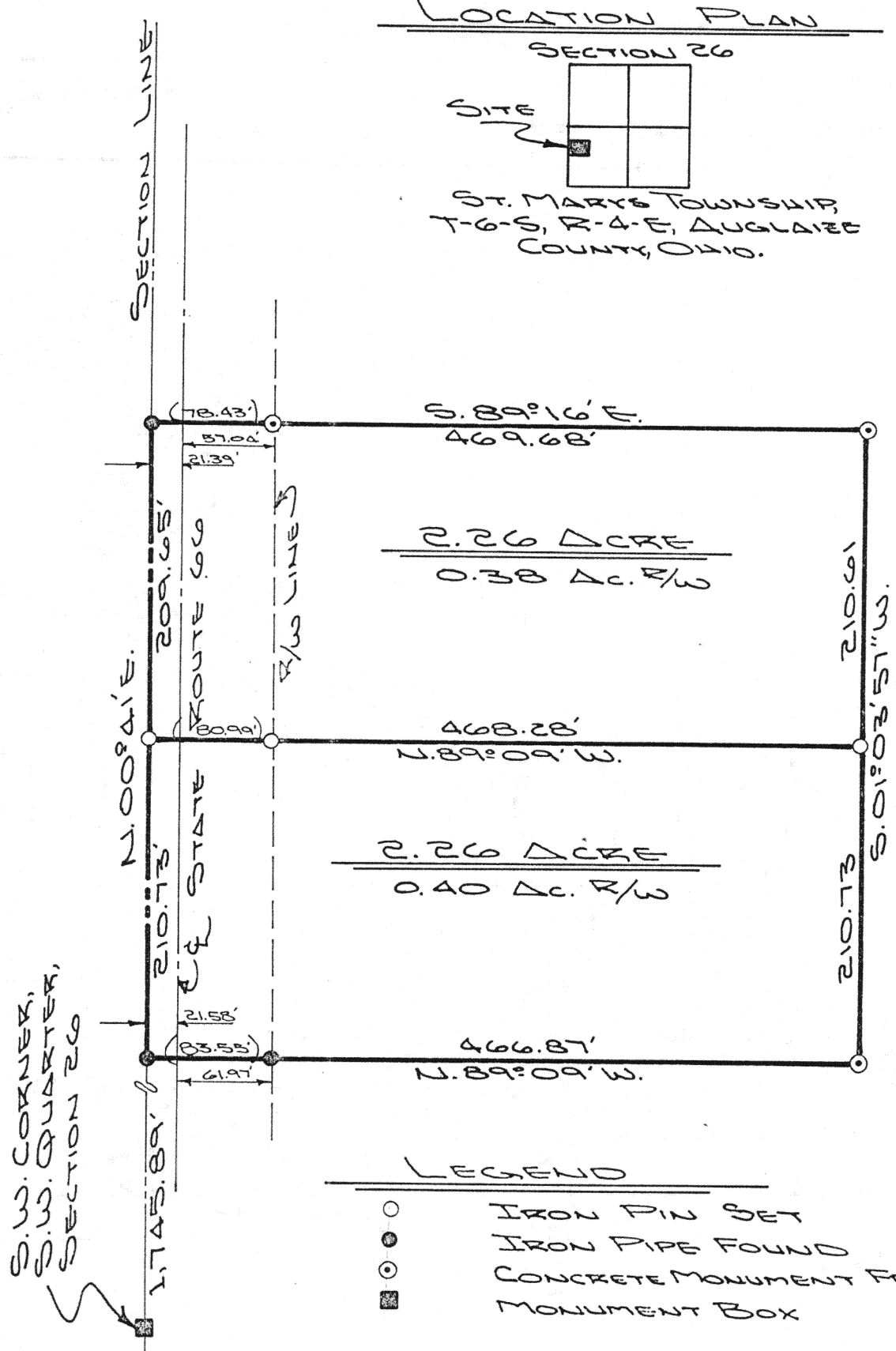




LOCATION PLAN  
SECTION 26



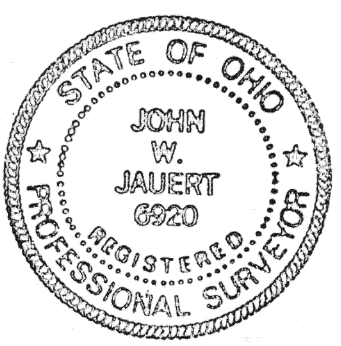
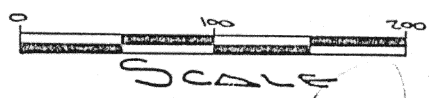


SURVEYOR'S DESCRIPTION

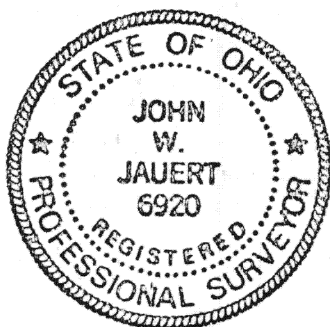
The following described tract of land is part of the Northwest Quarter of the Southwest Quarter of Section 26, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box over the stone at the Southwest corner of the Southwest Quarter of Section 26, St. Marys Township;  
thence N.00°41'E. along the West line of Section 26, St. Marys Township, a distance of 1,745.89 feet to an iron pipe found which is the PLACE OF BEGINNING for the tract of land herein described;  
thence continuing N.00°41'E. along the West line of Section 26, St. Marys Township, a distance of 420.38 feet to an iron pipe found;  
thence S.89°16'E. a distance of 469.68 feet to a concrete monument found, passing thru a concrete monument found for reference at 78.43 feet in the East right-of-way line of State Route 66;  
thence S.01°03'57"W. a distance of 421.34 feet to a concrete monument found;  
thence N.89°09'W. a distance of 466.87 feet to an iron pipe, passing thru an iron pipe found for reference at 383.32 feet in the East right-of-way line of State Route 66, said iron pipe was the true PLACE OF BEGINNING.

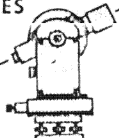
