The PLACE OF BEGINNING is at an iron pin set at the Northeast corner of Lot No. 58 of the Southmoor Shores Subdivision;

thence S.11°53'20"E. along the East property line of Lot No. 58, a distance of 92.68 feet to a point;

thence S.02°46'30"E. along the East property line of Lot No. 58, a distance of 20.00 feet to a point, which is the Southeast corner of Lot No. 58, Southmoor Shores Subdivision;

thence S.87°13'30"W. along the South property line of Lot No. 58, a distance of 30.00 feet to a point;

thence N.02°34'52"W. a distance of 111.38 feet to an iron pin set, passing thru an iron pin set for reference at 41.38 feet;

thence along the curved North property line of Lot No. 58, an arc distance of 15.00 feet, the chord of which bears N.86°42′19″E., 14.94 feet to an iron pin at the Northeast corner of Lot No. 58, which was the true PLACE OF BEGINNING.

Containing in all 2,646 square feet or 0.06 acre and being subject to all legal easements, restrictions and reservations, of record or in use on said premises.
