



SURVEYOR'S DESCRIPTION FOR 1.116 ACRE TRACT

The following described tract of land is part of the Northeast Quarter of the Northwest Quarter of Section 30, Town 5 South, Range 4 East, Noble Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northeast corner of the Northwest Quarter of Section 30, Noble Township, being in the intersection of the centerlines of Township Road 160 (Glynwood Road) and Township Road 15 (Koenig Road);

thence S.00°45'00"E. along the centerline of Township Road 15 and the East line of the Northwest Quarter of Section 30, Noble Township, a distance of 274.97 feet to a R.R. spike set which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.00°45'00"E. along the centerline of Township Road 15 and the East line of the Northwest Quarter of said Section 30, a distance of 202.60 feet to a R.R. spike found;

thence S.89°19'00"W. along the existing property line, a distance of 240.00 feet to an iron pin set, passing thru an iron pipe found at 25.00 feet in the West right-of-way line of Township Road 15;

thence N.00°45'00"W., parallel to the centerline of Township Road 15 and the East line of the Northwest Quarter of Section 30, a distance of 202.60 feet to an iron pin set;

thence N.89°19'00"E. a distance of 240.00 feet to a R.R. spike, passing thru an iron pin set for reference at 215.00 feet in the West right-of-way line of Township Road 15, said R.R. spike was the true PLACE OF BEGINNING.

Containing in all 1.116 acre of which 0.116 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
