thence continuing N.01° 01'28"E. along the West line of the Southwest Quarter of Section 1, a distance of 943.23 feet to an iron pin set;

thence S.44°33'10"E. a distance of 363.93 feet to an iron pin set;

thence S.03°26'57"W. a distance of 684.60 feet to a point;

thence S.89°54'24"W., parallel to the centerline of County Road 190 and the South line of the Southwest Quarter of Section 1, Duchouquet Township, a distance of 231.00 feet to a point which was the true PLACE OF BEGINNING.

thence N.01°01'29"E. a distance of 188.50 feet to a point;

thence N.03°26'57"E. a distance of 684.60 feet to an iron pin set;

thence N. 44° 33'10"W. a distance of 363.93 feet to an iron pin set;

thence N.01° 01'28"E. along the West line of the Southwest Quarter of

Section 1, a distance of 193.62 feet to an iron pin set;

thence S.89°37'34"E. along the North line of the Southwest Quarter of the Southwest Quarter of Section 1, a distance of 1,063.42 feet to an iron pin set;

thence S.00°59'20"W. a distance of 1,316.67 feet to a P.K. nail set in the centerline of County Road 190, passing thru an iron pin set for reference at 1,291.67 feet in the North right-of-way line of County Road

thence 5.89°54'24"W. along the centerline of County Road 190 and the South line of the Southwest Quarter of Section 1, a distance of 373.37 feet to a point;

thence N.00°05'35"W. a distance of 175.00 feet to a point;

thence S.89°54'24"W., parallel to the centerline of County Road 190, a distance of 110.00 feet to a point;

thence S.00°05'35"E. a distance of 175.00 feet to a point in the centerline of County Road 190;

thence S.89°54'24"W. along the centerline of County Road 190 and the South line of the Southwest Quarter of Section 1, a distance of 350.00 feet to a P.K. nail which was the PLACE OF BEGINNING.
