

SURVEYOR'S DESCRIPTION FOR PARCEL "A"

The following described tract of land is part of the Southwest Quarter of Section 22, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northwest corner of the Southwest Quarter of Section 22, Logan Township and in the centerline of County Road 101 (Conant Road);

thence S.00°31'06"E. along the centerline of County Road 101 and the West line of the Southwest Quarter of said Section 22, a distance of 1,464.19 feet to a R.R. spike found;


thence N.89°30'E. a distance of 175.00 feet to a point, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing N.89 30'E., a distance of 125.00 feet to an iron pipe found:

thence S.00° 30'E., a distance of 70.00 feet to an iron pin set; thence S.89° 30'W., a distance of 125.00 feet to an iron pin set;

thence N.00°30'W., a distance of 70.00 feet to a point, which was the true PLACE OF BEGINNING.

The following described tract of land is part of the Southwest Quarter of Section 22, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northwest corner of the Southwest Quarter of Section 22, Logan Township and in the centerline of County Road 101, (Conant Road);

thence S.00°31'06"E. along the centerline of County Road 101 and the West line of the Southwest Quarter of said Section 22, a distance of 1,604.19 feet to a R.R. spike set and the PLACE OF BEGINNING;

thence N.89°30'E., a distance of 175.00 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the East right-of-way line of County Road 101;


thence S.00°30'E., a distance of 50.00 feet to an iron pin set; thence S.89°30'W., a distance of 175.00 feet to a R.R. spike set in the centerline of County Road 101;

thence N.00°31'06"W. along the centerline of County Road 101 and the West line of the Southwest Quarter of Section 22, Logan Township, a distance of 50.00 feet to a R.R. spike, which was the true PLACE OF BEGINNING.
