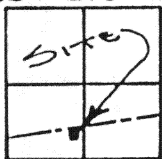


LOCATION PLAN

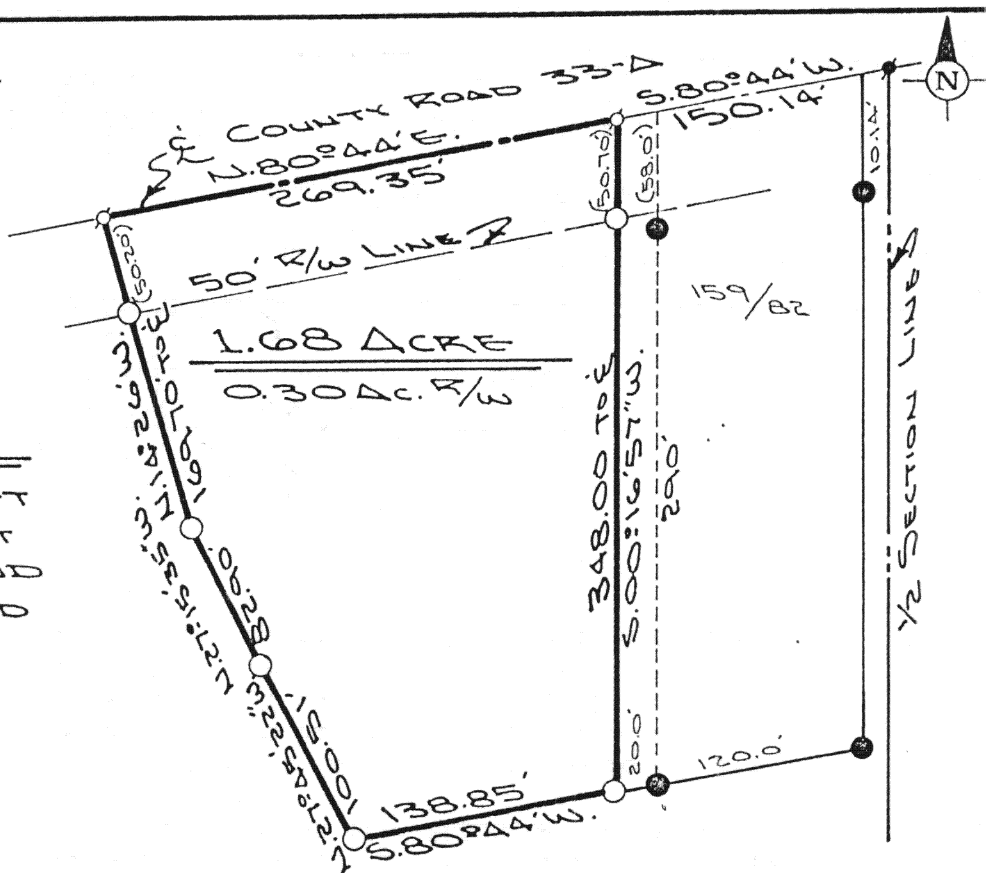
SECTION 34

The following described tract of land is part of the Southwest Quarter of Section 34, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a P.K. nail located at the intersection of the centerline of County Road 33-A and the East line of the Southwest Quarter of Section 34, Moulton Township;

thence S.80°44'W. along the centerline of County Road 33-A, a distance of 150.14 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described:

thence S.00°16'47\"W. along the West property line of James and Beulah Hughes and being parallel to the East line of the Southwest Quarter of said Section 34, a distance of 348.00 feet to an iron pin set, passing thru an iron pin set for reference at 50.70 feet in the South right-of-way line of County Road 33-A;

thence S.80°44'W., parallel to the centerline of County Road 33-A, a distance of 138.85 feet to an iron pin set;

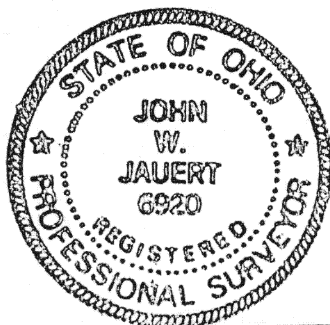
thence N.27°45'22\"W. a distance of 100.51 feet to an iron pin set;

thence N.27°15'35\"W. a distance of 82.90 feet to an iron pin set;

thence N.14°26\"W. a distance of 169.70 feet to a P.K. nail set, passing thru an iron pin set for reference at 119.50 feet in the South right-of-way line of County Road 33-A;

thence N.80°44'E. along the centerline of County Road 33-A, a distance of 269.35 feet to a P.K. nail which was the true PLACE OF BEGINNING.

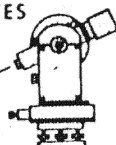
