

SURVEYOR'S DESCRIPTION FOR TRACT I-A

thence with a bearing of N. 89 -52'-50" E. along the North line of the Northwest quarter of said Section 10, and the centerline of Township Road #130, Goshen Road, for a distance of 567.32 feet to a Railroad Spike (set);

thence with a bearing of S. 00 -53'-10" E. for a distance of 252.51 feet to an iron pin (found);

thence with a bearing of S. 39 -22'-41" E. for a distance of 441.33 feet to an iron pin (found);

thence with a bearing of N. 00 -53'-10" W. for a distance of 594.26 feet to a Railroad Spike (set) on the North line of the Northwest quarter of said Section 10, and the centerline of Township Road # 130;


