



## SURVEYOR'S DESCRIPTION FOR PARCEL NO. 1

The following described tract of land is part of the Southeast Quarter of Section 14, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southwest corner of the Southeast Quarter of Section 14, Pusheta Township and in the centerline of County Road 110 (Freyburg East Road);'

thence S.90°00'E. along the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, a distance of 371.33 feet to a P.K. nail and the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°58'35"E. a distance of 1,290.16 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the North right-of-way line of County Road 110;

thence S.90°00'E., parallel to the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, Pusheta Township, a distance of 299.82 feet to an iron pin set;

thence S.01°10'35"W. a distance of 618.20 feet to an iron pin set; thence N.90°00'W., parallel to the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, a distance of 247.66 feet to an iron pin set;

thence S.00°58'35"W. a distance of 672.00 feet to a P.K. nail set, passing thru an iron pin set for reference at 647.00 feet in the North right-of-way line of County Road 110;

thence N.90°00'W. along the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, a distance of 50.00 feet to a P.K. nail, which was the true PLACE OF BEGINNING.

Containing in all 5.01 acre of which 0.02 acre has been dedicated for highway purposes. Commencing at a monument box at the Southwest corner of the Southeast Quarter of Section 14, Pusheta Township and in the centerline of County Road 110 (Freyburg East Road);'

thence S.90°00'E. along the centerline of County Road 110 and the South fline of the Southeast Quarter of Section 14, a distance of 421.33 feet to a P.K. nail and the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°58'35"E. a distance of 672.00 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the North right-of-way line of County Road 110;

thence S.90°00'E., parallel to the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, Pusheta Township, a distance of 247.66 feet to an iron pin set;

thence S.01°10'35"W. a distance of 672.04 feet to a P.K. nail set, passing thru an iron pin set for reference at 647.04 feet in the North right-of-way line of County Road 110:

thence N.90°00'W. along the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, a distance of 245.31 feet to a P.K. nail, which was the true PLACE OF BEGINNING.
