

The following described tract of land is part of the Southeast Quarter of the Northeast Quarter of Section 33, Town 7 South, Range 4 East, Jackson Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box over the stone found at the Southeast corner of the Northeast Quarter of Section 23, Jackson Township and in the centerline of County Road 46 (Wuebker Road);

thence with an assumed bearing of S.90°00'00"W. along the centerline of County Road 46 and the South line of the Northeast Quarter, a distance of 1,125.09 feet to a R.R. spike set and the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.90°00'00"W. along the above described line, a distance of 208.71 feet to a R.R. spike set;

thence N.00°57'52"E. along the West line of the Southeast Quarter of the Northeast Quarter of Section 23, a distance of 233.71 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the North right-of-way line of County Road 46;

thence N.90°00'00"E., parallel to the centerline of County Road 46, a distance of 208.71 feet to an iron pin set;

thence S.00°57'52"W. a distance of 233.71 feet to a R.R. spike, passing thru an iron pin set for reference at 208.71 feet in the North right-of-way line of County Road 46, said R.R. spike was the true PLACE OF BEGINNING.

Containing in all 1.12 acre of which 0.12 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 390, Page 57.
