

#### SURVEYOR'S DESCRIPTION

The following described tract of land is situated in the Southwest Quarter of Section 24, Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing at an Auglaize County Monument Box located at the Northeast Corner of the Southwest Quarter of Section 24, Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio;

THENCE with a bearing of S. 00°-37'00" E. along the East line of the Southwest Quarter of said Section 24, Moulton Township, for a distance of 2,098.95 feet to a Railroad Spike (found) on the centerline of County Road #158, Glynwood Road;

THENCE with a bearing of N:  $82^{\circ}$ - $47^{\circ}$ - $00^{\circ}$  W. along the centerline of County Road #158 for a distance of 175.00 feet to a P.K. Nail/Shiner (found) at the P.T. of a curve to the left;

THENCE along the centerline of County Road #158 following a curve to the left for an arc distance of 118.16 feet, of which a chord bears N. 88°-44'-04" W. for a distance of 117.95 feet to a P.K Nail/Shiner (set), said curve to the left having the following data: Delta =  $25^{\circ}-54'-42''$ , Radius (R) = 568.82 feet, and Tangent (T) = 130.86 feet, this point being the PLACE OF BEGINNING;

THENCE continuing along the centerline of County Road #158 following a curve to the left for an arc distance of 139.08 feet, of which a chord bears 5.78°-18'-35" W. for a distance of 138.74 feet to a P.K Nail/Shiner (found) at the P.C. of said curve to the left;

THENCE along the centerline of County Road #158 on a Tangent Section with a bearing of S. 71°-18'-18" W. for a distance of 58.19 feet to a P.K. Nail/Shiner (found) at the P.T. of a curve to the left;

THENCE along the centerline of County Road #158 following a curve to the left for an arc distance of 39.84 feet, of which a chord bears  $8.68^{\circ}-12'-41''$  W. for a distance of 39.82 feet to a P.K Nail/Shiner (set) at the centerline intersection of County Road #158, Glynwood Road, with Township Road #117A, Buckland River Road, said curve to the left having the following data: Delta =  $30^{\circ}-54'-53''$ , Radius (R) = 368.87 feet, and Tangent (T) = 102.00 feet;


THENCE continuing along the centerline of County Road #158 following a curve to the left for an arc distance of 159.19 feet, of which a chord bears  $5.52^{\circ}-45^{\circ}-13^{\circ}$  W. for a distance of 157.96 feet to a P.K Nail/Shiner (found) at the P.C. of the curve to the left, said curve having the following data: Delta =  $30^{\circ}-54^{\circ}-53^{\circ}$ , Radius (R) = 368.87 feet, and Tangent (T) = 102.00 feet;

THENCE with a bearing of N. 40°-23'-25" E. along a Tangent for a distance of 118.88 feet to a Railroad Spike (found) on the centerline of Township Road # 117A;

THENCE with a bearing of S. 84'-04'-15" W. along the centerline of Township Road #117A for a distance of 34.15 feet to a P.K. Nail/Shiner (set);

#### SURVEYOR'S DESCRIPTION

THENCE with a bearing of N. 00°-37°-00" W. for a distance of 436.78 feet to an iron pin (set), and passing thru an iron pin (set) on the Northerly right-of-way line of Township Road #117A at a distance of 30.13 feet;

THENCE with a bearing of N. 89°-23'-00" E. for a distance of 311.36 feet to an iron pin (set);

THENCE with a bearing of S. 00°-37'-00" E. for a distance of 370.00 feet to a P.K. Nail/Shiner (set) on the centerline of County Road #158, and passing thru an iron pin (set) on the Northerly right-of-way line of said Road at a distance of 344.94 feet, said point being the PLACE OF BEGINNING.

Containing in all 2.912 Acres of land subject to 0.219 Acre previous dedicated for highway purposes. The above described tract of land is also subject to all other legal easements, reservations, or restrictions of public knowledge, if any, upon said premises.
