COMMENCING AT A MONUMENT BOX OVER THE STONE FOUND AT THE SOUTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 17 AND IN THE INTERSECTION OF THE CENTERLINES OF COUNTY ROAD 50 (AMSTERDAM ROAD) AND TOWNSHIP ROAD 31 (TRI TOWNSHIP ROAD);

THENCE N. 89°52'55"W. ALONG THE CENTERLINE OF COUNTY ROAD 50 AND THE South line of the Southeast Quarter of Section 17, a distance of 305,40 feet to a P.K. nail set which is the PLACE OF BEGINNING FOR the tract of LAND HEREIN DESCRIBED;

THENCE CONTINUING N.89°52'55"W. ALONG THE CENTERLINE OF COUNTY ROAD 50 AND THE SOUTH LINE OF THE SOUTHEAST QUARTER OF SECTION 17, A DISTANCE OF 1,111.83 FEET TO A P.K. NAIL SET!

THENCE N.00°00'00"W, PARALLEL TO THE EAST LINE OF THE SOUTHEAST QUARTER OF SECTION 17, A DISTANCE OF 1,332.50 FEET TO A 5/8 INCH DIA, IRON PIN SET, PASSING THRU A 5/8 INCH DIA, IRON PIN SET FOR REFERENCE AT 25.00 TRON FEET IN THE NORTH RIGHT-OF-WAY LINE OF COUNTY ROAD 50;

THENCE S.89°49'11"E. A DISTANCE OF 1,417.24 FEET TO A P.K. NAIL SET IN

THE LAST LINE OF THE SOUTHEAST QUARTER OF SECTION 17,

THENCE S.00°00'00"E, PARALLEL TO THE CENTERLINE OF TOWNSHIP ROAD 31 AND THE EAST LINE OF THE SOUTHEAST QUARTER OF SECTION 17, A DISTANCE OF 474.37 FEET TO THE P.K. THENCE S.90°00'00"E, A DISTANCE OF 305.40 FEET TO A R.R. SPIKE FOUND IN

THE EAST LINE OF THE SOUTHEAST QUARTER OF SECTION 17;

THENCE S.00°00'00"E, ALONG THE EAST LINE OF THE SOUTHEAST QUARTER OF Section 17 and the centerline of Township Road 31, a distance of 175,00 feet TO THE MONUMENT BOX, WHICH WAS THE TRUE PLACE OF BEGINNING,
