

SURVEYOR'S DESCRIPTION

THE FOLLOWING DESCRIBED TRACT OF LAND IS SITUATED IN THE SOUTH HALF OF THE SOUTHWEST QUARTER OF SECTION 29, GOSHEN TOWNSHIP, TOWN-5-SOUTH, RANGE-&-EAST, AUGLAIZE COUNTY, OHIO, AND IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN AUGLAIZE COUNTY MONUMENT BOX LOCATED AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 29, GOSHEN TOWNSHIP, TOWN-5-SOUTH, RANGE-B-EAST, AUGLAIZE COUNTY, OHIO;

THENCE WITH A BEARING OF N. 00°-35'-45" E. ALONG THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 29, AND THE CENTERLINE OF COUNTY ROAD #261, WAYNESFIELD ROAD, FOR A DISTANCE OF 752.00 FEET TO A P.K. NAIL/SHINER (SET) AND THE PLACE OF BEGINNING;

THENCE CONTINUING ALONG THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 29, AND THE CENTERLINE OF COUNTY ROAD #261, WAYNESFIELD ROAD, FOR A DISTANCE OF 573.09 FEET TO A P.K. NAIL/SHINER (SET);

THENCE WITH A BEARING OF S. 89°-58'-35" E. ALONG THE NORTH LINE OF THE SOUTH HALF OF THE SOUTHWEST QUARTER OF SAID SECTION 29 FOR A DISTANCE OF 206.00 FEET TO AN IRON PIN (SET), AND PASSING THRU AN IRON PIN (SET) LOCATED ON THE EASTERLY RIGHT-OF-WAY LINE OF COUNTY ROAD #261, WAYNESFIELD ROAD, AT A DISTANCE OF 25.00 FEET;

THENCE WITH A BEARING OF S. 00^{o} – 35° –45'' W. FOR A DISTANCE OF 573.09 FEET TO AN IRON PIN (SET);

THENCE WITH A BEARING OF N, 89°-58'-33" W. FOR A DISTANCE OF 206.00 FEET TO A P.K. NAIL/SHINER (SET) LOCATED ON THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 29, AND THE CENTERLINE OF COUNTY ROAD #261, WAYNESFIELD ROAD, AND PASSING THRU AN IRON PIN (SET) LOCATED ON THE EASTERLY RIGHT-OF-WAY LINE OF SAID ROAD AT A DISTANCE OF 181.00 FEET, SAID P.K. NAIL/SHINER BEING THE ORIGINAL PLACE OF BEGINNING:

CONTAINING IN ALL, 2.710 ACRES OF LAND, OF WHICH, 0.329 ACRE BEING PREVIOUSLY DEDICATED FOR HIGHWAY PURPOSES. 
