



SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Northeast Quarter of Section 32, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box found at the Northeast corner of the Northeast Quarter of Section 32, Moulton Township and in the centerline of County Road 91 (Moulton - Ft. Amanda Road);

thence S.01°30'00"W. along the centerline of County Road 91 and the East line of the Northeast Quarter of Section 32, a distance of 383.85 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.01°30'00"W. along the centerline of County Road 91 and the East line of the Northeast Quarter of Section 32, a distance of 469.00 feet to a P.K. nail set;

thence N.87°30'00"W. a distance of 200.03 feet to an iron pin found, passing thru an iron pin set for reference at 25.00 feet in the West right-of-way line of County Road 91;


thence S.01°30'00"W., parallel to the centerline of County Road 91 and the East line of the Northeast Quarter of Section 32, a distance of 472.73 feet to an iron pin set;

thence N.88°46'13"W. along the South line of the Northeast Quarter of the Northeast Quarter of Section 32, a distance of 331.44 feet to an iron pin set;

thence N.01°30'00"E., parallel to the centerline of County Road 91 and the East line of the Northeast Quarter of Section 32, a distance of 937.14 feet to an iron pin set;

thence S.88°47°15″E. a distance of 531.44 feet to a P.K. nail, passing thru an iron pin set for reference at 506.44 feet in the West right-of-way line of County Road 91, said P.K. nail was the true PLACE OF BEGINNING.

Containing in all 9.274 acre of which 0.269 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 71, page 206.
