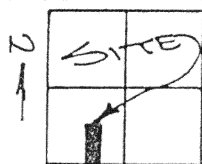


# LOCATION PLAN

## SECTION 15

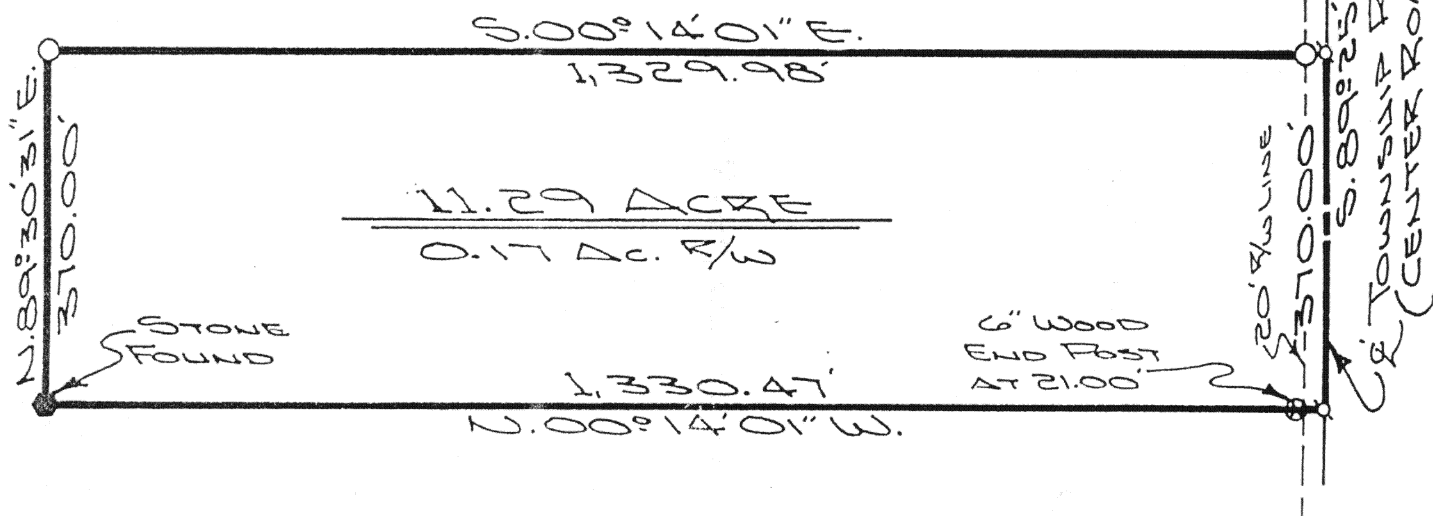


WASHINGTON TOWNSHIP,

The following described tract of land is part of the Southeast Quarter of the Southwest Fractional Quarter of Section 15, Town 6 South, Range 5 East, Washington Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Southwest Fractional Quarter of Section 15, Washington Township and in the centerline of Township Road 110 (Center Road);

thence S.89°25'55"W. along the South line of the Southwest Quarter and the centerline of Township Road 110, a distance of 301.68 feet to a P.K. nail which is the **PLACE OF BEGINNING** for the tract of land herein described;

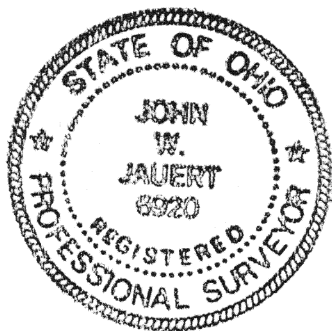
thence continuing S.89°25'55"W. along the above described line, a distance of 370.00 feet to a P.K. nail set;

thence N.00°14'01"W. a distance of 1,330.47 feet to a stone found, passing thru a 6 inch wood end post at 21.00 feet;

thence N.89°30'31"E. a distance of 370.00 feet to an iron pin set;

thence S.00°14'01"E. a distance of 1,329.98 feet to a P.K. nail, passing thru an iron pin set for reference at 1,309.98 feet in the North right-of-way line of Township Road 110, said P.K. nail was the true **PLACE OF BEGINNING**.

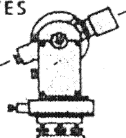
