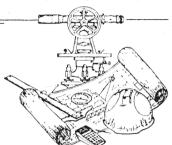

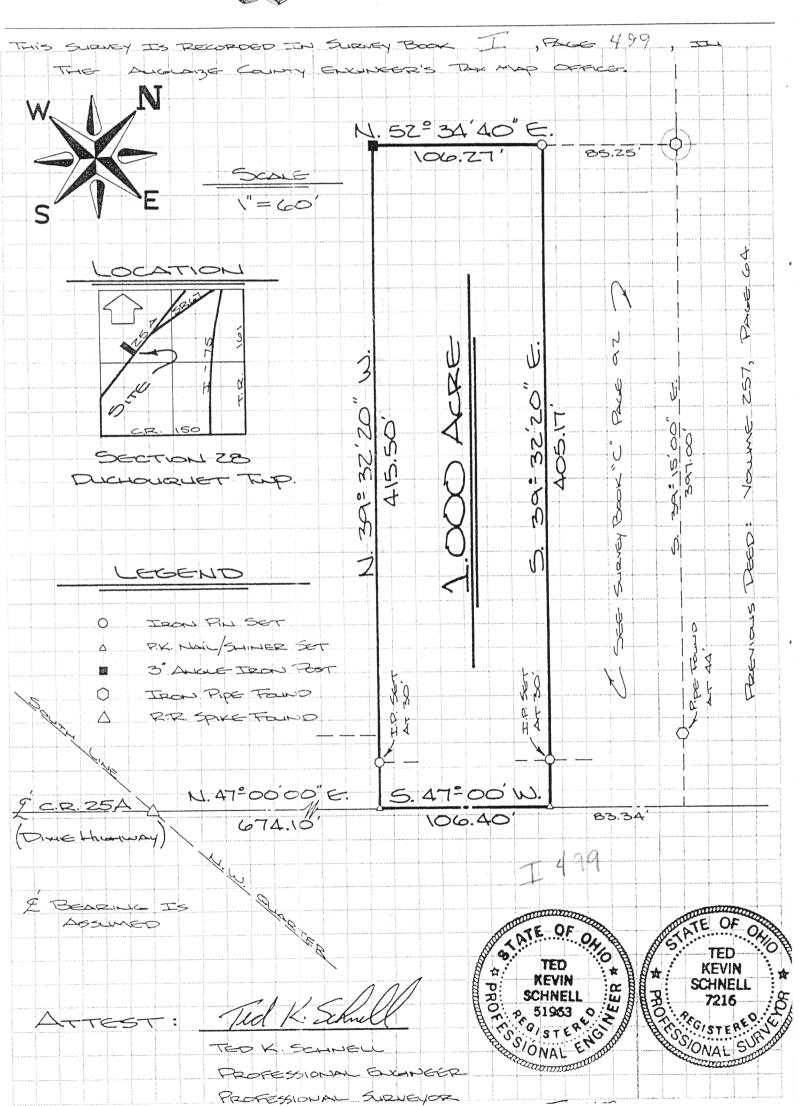

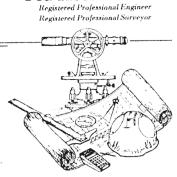

SURVEYOR'S DESCRIPTION

THE FOLLOWING TRACT OF LAND IS SITUATED IN THE NORTHWEST QUARTER OF SECTION 28, DUCHOUQUET TOWNSHIP, TOWN-5-SOUTH, RANGE-6-EAST, AUGLAIZE COUNTY, OHIO, AND IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE SOUTH LINE OF THE NORTHWEST QUARTER OF SAID SECTION 28, WITH THE CENTERLINE OF NORTH DIXIE HIGHWAY, ALSO REFERRED TO AS WOOD STREET OR C.R. 25A;

THENCE WITH AN ASSUMED BEARING OF N. 470-00'-00" E. ALONG THE CENTERLINE OF SAID ROAD FOR A DISTANCE OF 674.10 FEET TO A P.K. NAIL/SHINER (SET) AND THE PLACE OF BEGINNING;

THENCE WITH A BEARING OF N. 390-32'-20" W. FOR A DISTANCE OF 415.50 FEET TO A 3" ANGLE IRON CORNER POST, AND PASSING THRU AN IRON PIN (SET) ON THE WESTERLY RIGHT-OF-WAY LINE OF SAID ROAD AT A DISTANCE OF 30.00 FEET;

THENCE WITH A BEARING OF N. 520-34'40" E. FOR A DISTANCE OF 106.27 FEET TO AN IRON PIN (SET);

THENCE WITH A BEARING OF S. 390-32'-20" E. FOR A DISTANCE OF 405.17 FEET TO A P.K. NAIL/SHINER (SET) ON THE CENTERLINE OF SAID ROAD, AND PASSING THRU AN IRON PIN (SET) ON THE WESTERLY RIGHT-OF-WAY LINE OF SAID ROAD AT A DISTANCE OF 375.17 FEET;

THENCE WITH A BEARING OF S. 470-00'-00" W. ALONG THE CENTERLINE OF SAID ROAD FOR A DISTANCE OF 106.40 FEET TO A P.K. NAIL/SHINER (SET) AND THE PLACE OF BEGINNING.

CONTAINING IN ALL 1.000 ACRE OF WHICH 0.073 ACRE BEING PREVIOUSLY DEDICATED FOR HIGHWAY PURPOSES. THE ABOVE DESCRIBED TRACT OF LAND IS ALSO SUBJECT TO ALL LEGAL EASEMENTS, RESERVATIONS, OR RESTRICTIONS, IF ANY, UPON SAID PREMISES.
