

SURVEYOR'S DESCRIPTION

The following described tract of land is part of Lot No. 4 and part of Lot No. 5 of the Meekers Subdivision to the City of Wapakoneta, Section 28, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at the Northwest corner of Lot No. 5 of the Meekers Subdivision in the City of Wapakoneta;

thence South along the East right-of-way line of Wood Street a distance of 7.00 feet to a R.R. spike found;

thence Easterly along the South right-of-way of a 14 foot alley a distance of 201.00 feet to a R.R. spike found and the PLACE OF BEGINNING for the tract of land herein described;

thence continuing easterly along the South right-of-way line of a 14 foot alley, a distance of 104.15 feet to an iron pin set;

thence with an interior angle of 89 09'3\$", along the West right-of-way line of Wentz Street, a distance of 127.75 feet to a R.R. spike set;

thence with an interior angle of 89 35'50", along the North right-of-way line of relocated Lima Street, a distance of 104.15 feet to a R.R. spike set;

thence with an interior angle of 90 24'00" a distance of 125.49 feet to the R.R. spike which was the true PLACE OF BEGINNING.

Containing in all 13,187 Sq. Feet. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises.
