Commencing at a R.R. spike (O.D.O.T. sta. 256+08) found in the intersection of the centerlines of State Route 198 and Township Road 180 (Wapak-Buckland Road);

thence S.23°59'30"E. (as per O.D.O.T. Right-of-way plans) along the centerline of State Route 198, a distance of 879.01 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.65°38'41"E. a distance of 151.81 feet to an iron pipe found, passing thru an iron pin found at 29.76 feet;

thence S.88°18'03"E. a distance of 684.80 feet to a 6 inch dia. wooden corner post found in the Moulton - Duchouquet Township line;

thence S.01°37'37"W. along the Township line and the East line of the Northeast Quarter of Section 13, Moulton Township, a distance of 219.10 feet to an iron pin set;

thence N.88°02'50"W., parallel to the North line of the Northeast Quarter of Section 13, a distance of 580.92 feet to an iron pin set;

thence S.65°38'41"W. a distance of 151.81 feet to a P.K. nail, passing thru an iron pin set for reference at 121.81 feet in the Easterly right-of-way line of State Route 198;

thence N.23°59'30"W. along the centerline of State Route 198, a distance of 240.24 feet to the P.K. nail which was the true PLACE OF BEGINNING.

thence S.23°59'30"E. (as per O.D.O.T. Right-of-way plans) along the centerline of State Route 198, a distance of 1,119.25 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.65°38'41"E. a distance of 151.81 feet to an iron pin set, passing thru an iron pin set at 30.00 feet in the Easterly right-of-way line of State Route 198;

thence S.88°02'50"E., parallel to the North line of the Northeast Quarter of Section 13, Moulton Township, a distance of 342.12 feet to an iron pin set;

thence S.01°37'37"W., parallel to the Township line and the East line of the Northeast Quarter of Section 13, Moulton Township, a distance of 182.13 feet to an iron pin set;
