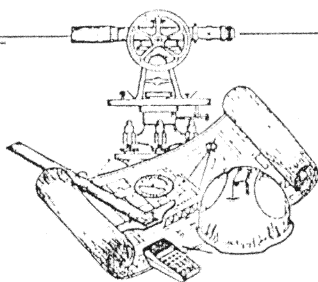

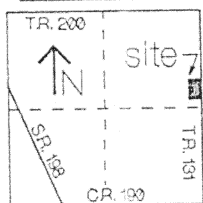


Northeast Corner of the Southeast Quarter of the

Location



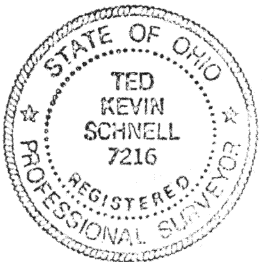
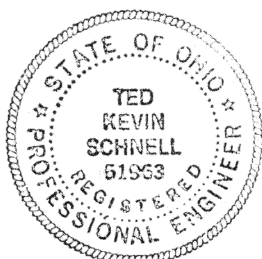

SURVEYOR'S DESCRIPTION

THE FOLLOWING DESCRIBED TRACT OF LAND IS SITUATED IN THE NORTHEAST QUARTER OF SECTION 1, LOGAN TOWNSHIP, TOWN-5-SOUTH, RANGE-5-EAST, AUGLAIZE COUNTY, OHIO, AND IS MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT AN AUGLAIZE COUNTY MONUMENT BOX LOCATED AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 1, LOGAN TOWNSHIP, TOWN-5-SOUTH, RANGE-5-EAST, AUGLAIZE COUNTY, OHIO;

THENCE WITH A BEARING OF S. 00°-40'-24" E. ALONG THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 1 FOR A DISTANCE OF 1,327.80 FEET TO A P.K. NAIL (FOUND) AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 1;

THENCE CONTINUING WITH A BEARING OF S. 00°-40'-24" E. ALONG THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 1 FOR A DISTANCE OF 660.00 FEET TO A P.K. NAIL (SET);

THENCE WITH A BEARING OF N. 89°-53'-20" W. AND PARALLEL WITH THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 1 FOR A DISTANCE OF 150.00 FEET TO AN IRON PIN (SET) AND THE PLACE OF BEGINNING;

THENCE WITH A BEARING OF S. 00°-40'-24" E. AND PARALLEL WITH THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 1 FOR A DISTANCE OF 290.00 FEET TO AN IRON PIN (SET);

THENCE WITH A BEARING OF N. 89°-53'-20" W. AND PARALLEL WITH THE SOUTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION 1 FOR A DISTANCE OF 30.00 FEET TO AN IRON PIN (SET);

THENCE WITH A BEARING OF N. 00°-40'-24" W. AND PARALLEL WITH THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 1 FOR A DISTANCE OF 290.00 FEET TO AN IRON PIN (SET);

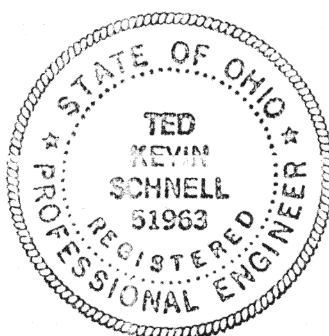
