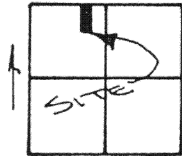


LOCATION PLAN

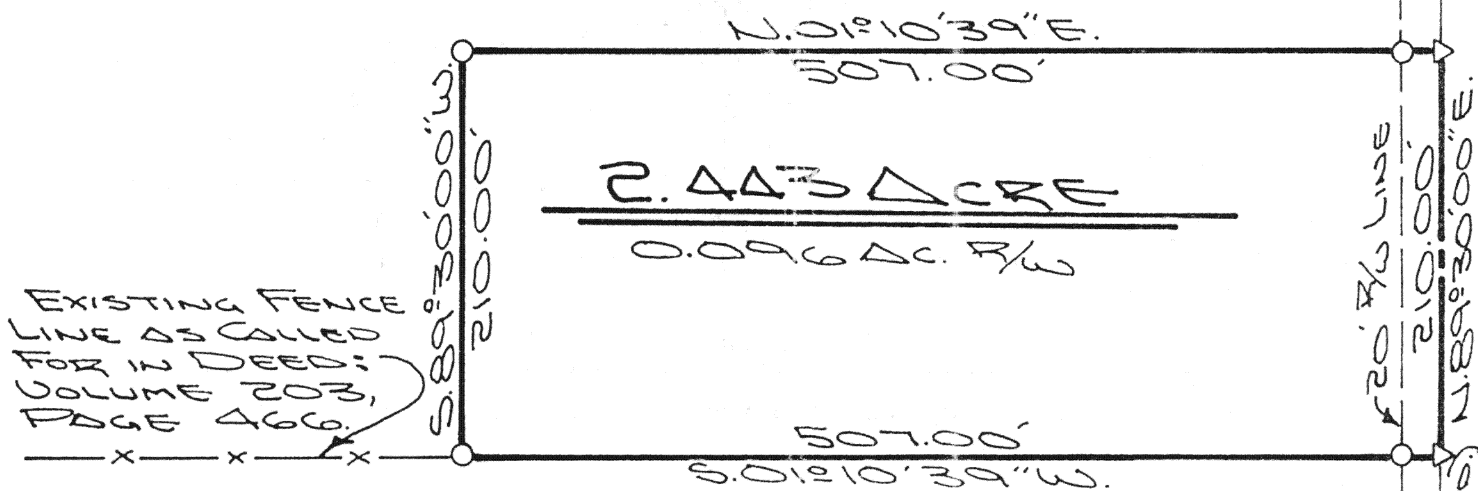
SECTION 28

The following described tract of land is part of the Northeast Quarter of the Northwest Quarter of Section 28, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at the stone found inside the Auglaize County Monument Box located at the Northeast corner of the Northwest Quarter of Section 28, Logan Township and in the centerline of Township Road 220 (Burnfield Road);

thence with an assumed bearing of S.89°30'00\"W. along the centerline of Township Road 220 and the North line of the Northwest Quarter of Section 28, a distance of 584.79 feet to a R.R. spike set, which is the PLACE OF BEGINNING for the tract of land herein described;

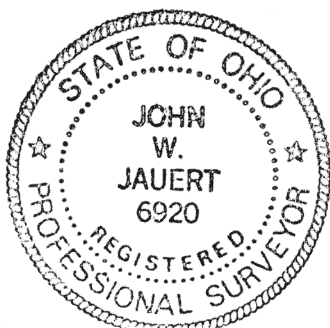
thence S.01°10'39\"W., along an existing fence line as described in Deed Volume 203, page 466, a distance of 507.00 feet to a 5/8\" dia. iron pin set, passing thru a 5/8\" dia. iron pin set for reference at 20.01 feet in the South right-of-way line of Township Road 220;

thence S.89°30'00\"W., parallel to the centerline of Township Road 220 and the North line of the Northwest Quarter of Section 28, a distance of 210.00 feet to a 5/8\" dia. iron pin set;

thence N.01°10'39\"E. a distance of 507.00 feet to the R.R. spike set, passing thru a 5/8\" dia. iron pin set for reference at 486.99 feet in the South right-of-way line of Township Road 220;

thence N.89°30'00\"E. along the centerline of Township Road 220 and the North line of the Northwest Quarter of Section 28, Logan Township, a distance of 210.00 feet to the R.R. spike which was the true PLACE OF BEGINNING.

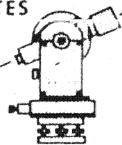
