



SURVEYOR'S DESCRIPTION FOR PARCEL NO. 1

The following described tract of land is part of the Northwest Quarter of Section 5, Town 6 South, Range 7 East, Clay Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a R.R. spike found at the intersection of the centerlines of Center Street and County Road 207 (Geyer Road);

thence with an assumed bearing of S.00°00'00"W. along the centerline of County Road 207, a distance of 1,219.73 feet to a R.R. spike set which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing \$.00°00'00"W. along the centerline of County Road 207, a distance of 200.00 feet to a R.R. spike set;

thence S.89°35'21"W. a distance of 551.87 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the West right-of-way line of County Road 207;

thence N.00°00'00"E., parallel to the centerline of County Road 207, a distance of 200.00 feet to an iron pin set;

thence N.89°35'21"E. a distance of 551.87 feet to a R.R. spike, passing thru an iron pin set for reference at 526.87 feet in the West right-of-way line of County Road 207, said R.R. spike was the true PLACE OF BEGINNING.

Containing in all 2.534 acre of which 0.102 acre has been dedicated for highway purposes. thence continuing S.00°00'00"W. along the centerline of County Road 207, a distance of 178.00 feet to a R.R. spike found;

thence S.89°35'21"W. a distance of 551.87 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the West right-of-way line of County Road 207;

thence N.00°00'00"E., parallel to the centerline of County Road 207, a distance of 200.00 feet to an iron pin set;

thence N.89°35'21"E. a distance of 551.87 feet to a R.R. spike, passing thru an iron pin set for reference at 526.87 feet in the West right-of-way line of County Road 207, said R.R. spike was the true PLACE OF BEGINNING.

Containing in all 2.255 acre of which 0.115 acre has been dedicated for highway purposes.
