

SURVEYOR'S DESCRIPTION FOR PARCEL NO. 1



The following described tract of land is part of the Southeast Quarter of Section 29 and part of the Northeast Quarter of Section 32, Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Southeast corner of the Southeast Quarter of Section 29, Moulton Township and in the centerline of County Road 91 (Moulton-Ft. Amanda Road);

thence N.01°22'45"E. along the centerline of County Road 91 and the East line of the Southeast Quarter of Section 29, a distance of 491.20 feet to a P.K. nail found;

thence S.88°48'35"E. along the existing property line as agreed upon and recorded in Plat Cabinet "A", slide 153, in the Auglaize County Recorder's Office, a distance of 404.21 feet to a point in the centerline of the Six Mile open ditch, which is the **PLACE OF BEGINNING** for the tract of land herein described;

thence S.33°51'51"W. along the centerline of the open ditch, a distance of 355.69 feet to a point;

thence S.84°13'26"W. along the centerline of the open ditch, a distance of 413.55 feet to a point;

thence S.55°38'43"W. along the centerline of the open ditch, a distance of 186.39 feet to a point;

thence S.40°27'56"W. along the centerline of the open ditch, a distance of 126.23 feet to a point;

thence S.55°58'34"W. along the centerline of the open ditch, a distance of 1,534.47 feet to a point;

thence S.72°19'25"W. along the centerline of the open ditch, a distance of 146.73 feet to an iron pin set;

thence N.02°08'26"E. along the West line of the Northeast Quarter of Section 32, a distance of 998.37 feet to a point at the Northwest corner of the Northeast Quarter of Section 32, Moulton Township;

thence N.01°12'50"E. along the West line of the Southeast Quarter of Section 29, Moulton Township, a distance of 589.97 feet to a point, being referenced by a 10 inch wood end post found at S.88°11'25"E., at a distance of 3.01 feet;

thence S.88°11'25"E. along the existing property line as agreed upon and recorded in Plat Cabinet "A", slide 153, in the Auglaize County Recorder's Office, a distance of 1,292.57 feet to an iron pipe found, passing thru a 10 inch wood end post found at 3.01 feet;

thence S.04°20'15"E. along the existing property line, a distance of 86.71 feet to an iron pipe found;

thence S.88°48'35"E. along the existing property line, a distance of 908.95 feet to the point which was the true PLACE OF BEGINNING.

Containing in all 41.844 acre, 24.269 acre being in Section 29 and 17.575 acre being in Section 32, Moulton Township. The above tract of ground is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference, Volume OR 71, page 206. SURVEYOR'S DESCRIPTION FOR PARCEL NO. 2

The following described tract of land is part of the Southeast Quarter of Section 29 and part of the Northeast Quarter of Section 32. Town 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northeast corner of the Northeast Quarter of Section 32, Moulton Township and in the centerline of County Road 91 (Moulton-Ft. Amanda Road);

thence S.01°30'00"W, along the centerline of County Road 91 and the East line of the Northeast Quarter of Section 32, a distance of 329.30 feet to a R.R. spike found, which is the **PLACE OF BEGINNING** for the tract of land herein described;

thence continuing S.01°30'00"W. along the above described line, a distance of 54.55 feet to a P.K. nail set;

thence N.88°47'15"W. a distance of 531.44 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the West right of way line of County Road 91;

thence S.01°30'00"W., parallel to the centerline of County Road 91 and the East line of the Northeast Quarter of Section 32, a distance of 937.14 feet to an iron pin set;

thence N.88°46'13"W. a distance of 782.26 feet to an iron pin set;

thence N.01°49'13"E. a distance of 322.77 feet to an iron pin set;

thence N.88°46'36"W, a distance of 1,311.90 feet to an iron pin set;

thence N.72°19'25"W, along the centerline of the open ditch, a distance of 146.73 feet to a point;

thence N.55°58'34"E. along the centerline of the open ditch, a distance of 1,534.47 feet to a point;

thence N.40°27'56"E. along the centerline of the open ditch, a distance of 126.23 feet to a point;

thence N.55°38'43"E. along the centerline of the open ditch, a distance of 186.39 feet to a point;


thence N.84°13'26"E. along the centerline of the open ditch, a distance of 413.55 feet to a point;

thence S.88°47'15"E. a distance of 64.21 feet to an iron pin found;

thence S.01°30'00"W. a distance of 520.86 feet to an iron pin set;

thence S.88°47'15"E. a distance of 531.44 feet to a R.R. spike, passing thru an iron pin set for reference at 506.44 feet in the West right-of-way line of County Road 91, said R.R. spike was the true PLACE OF BEGINNING.
