## SURVEYOR'S DESCRIPTION FROM CHURCH TO TOWNSHIP TRUSTEES

The following described tract of land is part of the Northeast Quarter of Section 15, Town 6 South, Range 7 East, Clay Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument box at the Southwest corner of the Northeast Quarter of Section 15, Clay Township and in the centerline of County Road 116 (Gutman Road);

thence with an assumed bearing of N.90°00'00"E. along the South line of the Northeast Quarter of Section 15 and the centerline of County Road 116, a distance of 404.25 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°01'05"E. a distance of 115.50 feet to a point; thence N.90°00'00"E. a distance of 15.75 feet to an iron pin set;

thence S.00°01'05"W. a distance of 115.50 feet to a P.K. nail set in the centerline of County Road 116, passing thru an iron pin set for reference at 81.50 feet;

thence S.90°00'00"W. along the centerline of County Road 116 and the South line of the Northeast Quarter of Section 15, a distance of 15.75 feet to the P.K. nail which was the true PLACE OF BEGINNING.

Containing in all 0.056 acre of which 0.009 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed references: Volume 44, page 422 and Volume 79. This plat is recorded in Survey Book "I", page 766, in the Auglaize County Engineer's Office.

Commencing at a Monument box at the Southwest corner of the Northeast Quarter of Section 15, Clay Township and in the centerline of County Road 116 (Gutman Road);

thence with an assumed bearing of N.90°00'00"E. along the South line of the Northeast Quarter of Section 15 and the centerline of County Road 116, a distance of 420.00 feet to a P.K. nail set;

thence N.00°01'05"E. a distance of 115.50 feet to an iron pin set, passing thru an iron pin set for reference at 34.00 feet;

thence N.90°00'00"E., parallel to the South line of the Northeast Quarter of Section 15 and the centerline of County Road 116, a distance of 100.79 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.34°30'40"E. a distance of 32.16 feet to an iron pin

thence N.90°00'00"E., parallel to the South line of the Northeast Quarter of Section 15 and the centerline of County Road 116, a distance of 55.00 feet to an iron pin set;

thence S.00°01'05"W. a distance of 26.50 feet to a point; thence S.90°00'00"W., parallel to the centerline of County Road 116 and the South line of the Northeast Quarter of Section 15, a distance of 73.21 feet to the iron pin which was the crue PLACE OF BEGINNING.
