



## SURVEYOR'S DESCRIPTION OF 5.01 ACRE TRACT

thence S.89°37'45"E. along the North line of the Northeast Quarter of Section 27 and the centerline of Township Road 160, a distance of 504.30 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing S.89°37'45"E. along the North line of the Northeast Quarter of Section 27 and the centerline of Township Road 160, a distance of 205.70 feet to a P.K. nail set;

thence S.00°33'00"W. along the East property line as described in Deed Volume OR 77, page 27, a distance of 785.45 feet to an iron pin set;

thence N.89°17'24"W. a distance of 321.19 feet to an iron pin set;

thence N.00°33'00"E. a distance of 475.05 feet to an iron pin set;

thence N.76°19'42"E. a distance of 117.53 feet to an iron pin found;

thence N.00°52'15"E. along the East line of a 2.003 acre tract of land as found recorded in Survey Book "J", page 227, in the Auglaize County Engineer's Office, to the P.K. nail which was the true PLACE OF BEGINNING.

Containing in all 5.01 acre of which 0.07 acre has been dedicated for highway purposes. thence S.89°37'45"E. along the North line of the Northeast Quarter of Section 27 and the centerline of Township Road 160, a distance of 710.00 feet to a P.K. nail set;

thence S.00°33'00"W. along the East property line as described in Deed Volume OR 77, page 27, a distance of 785.45 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing \$.00°33'00"W. along the above described line, a distance of 541.12 feet to an iron pin set;

thence N.89°17'24"W. along the 1/4 Section line, a distance of 321.19 feet to an iron pin set;

thence N.00°33'00"E. a distance of 541.12 feet to an iron pin set;

thence S.89°17'24"E. a distance of 321.19 feet to the iron pin which was the true PLACE OF BEGINNING.
