DESCRIPTION TRACTI

Being a part of the southwest fractional quarter of the south-west fractional quarter of Section 15, T-6-S, R-7-E, Clay Township, Auglaize County, Ohio and being more particularly described as follows:


Commencing at a railroad spike at the northeast corner of the northwest fractional quarter of the southwest fractional quarter of said Section 15 and the centerline intersection of State Route 65 and Gutman Road; thence with an assumed bearing of S 00°00'00"W along the east line of the westerly fractional one-half of the southwest fractional quarter of said Section 15 and the centerline of State Route 65 for a distance of 1,319.45 feet to a cotton gin spindle (set) at the northeast corner of the southwest fractional quarter of the southwest fractional quarter of said Section 15, and the PLACE OF BEGINNING;

thence continuing along said line and centerline S $00^{\circ}00'00''W$ for a distance of 389.54 feet to a cotton gin spindle (set);

thence N $88^{\circ}24'12"W$ (passing through a 5/8" re-rod w/cap set at a distance of 30.00 feet) for a total distance of 187.00 feet to a 5/8" re-rod w/cap (set);

thence N 00°00'00"E for a distance of 389.54 feet to a 5/8" re-rod w/cap (set) on the north line of the southwest fractional quarter of the southwest fractional quarter of said Section 15;

thence S 88°24'12"E along the aforesaid line (passing through a 5/8" re-rod w/cap set at a distance of 157.00 feet) for a total distance of 187.00 feet to the PLACE OF BEGINNING, containing therein 1.671 acres more or less, of which 0.268 acres is road right-of-way.

Commencing at a railroad spike at the northeast corner of the northwest fractional quarter of the southwest fractional quarter of said Section 15 and the centerline intersection of State Route 65 and Gutman Road; thence with an assumed bearing of S 00°00'00"W along the east line of the westerly fractional one-half of the southwest fractional quarter of said Section 15 and the centerline of State Route 65 for a distance of 1,708.99 feet to a cotton gin spindle (set) and the PLACE OF BEGINNING;

thence continuing S 00°00'00"W along said line and centerline for a distance of 277.46 feet to a cotton gin spindle (set);

thence N 88°24'12"W (passing through a 5/8" re-rod w/cap set at a distance of 30.00 feet) for a total distance of 187.00 feet to a 5/8" re-rod w/cap (set);

thence N 00°00'00"E for a distance of 277.46 feet to a 5/8" re-rod w/cap (set);

thence S $88^{\circ}24'12"E$ (passing through a 5/8" re-rod w/cap set at a distance of 157.00 feet) for a total distance of 187.00feet to the PLACE OF BEGINNING, containing therein 1.191 acres more or less, of which, 0.191 acres is road right-of-way.
