


Part of the SW /4 of Section 6, T.6-5, R-8-E, Goshen Township, Auglaize County, Ohio.

DESCRIPTION PARCEL "A"

Being a part of the of the Southwest Quarter of Section 6, T-6-S, R-8-E, Goshen Township, Auglaize County, Ohio as evidenced by OR Vol. 110, Page 502 and more particularly described as follows:

Commencing at a monument box marking the location of the southwest corner of the southwest quarter of said Section 6 and the centerline of Santa Fe Line Road; N 00 degrees 00' 00" E for a distance of 1327.30 feet to a p-k nail as established by Richard Morrisey, PS 6470 and evidenced by OR Vol. 110, Pg. 502; thence N 89 degrees 34' 05" E along Swartz Road for a distance of 715.00 feet to a Cotton Gin Spindle (set) and the PLACE OF BEGINNING for the parcel herein described;

thence N 00 degrees 00' 00" E (passing through a 5/8" re-rod w/cap set for reference at a distance of 20.00 feet) for a total distance of 440.00 feet to a 5/8" re-rod w/cap (set);

thence N 89 degrees 34^{\pm} 05" E for a distance of 275.00 feet to a 5/8" re-rod w_{ℓ} cap (found);

thence S 00 degrees 00' 00" W (passing through a 5/8" re-rod w/cap found at a distance of 420.00 feet) for a total distance of 440.00 feet to a p-k nail (found):
