DESCRIPTION

Being a parcel of land situate in the Northeast quarter of Section 19, T-5-S, R-8-E, Wayne Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box found at the southeast corner of said Northeast quarter of said Section 19; thence N 00°06'30" E with the east line of said Northeast quarter (also the centerline of Waynesfield Road), 653.00 feet to a PK nail set and the PLACE OF BEGINNING; thence continuing N 00°06'30" E with said east line and centerline, 336.00 feet to a PK nail set; thence N 89°50'07" W (passing through a 5/8 inch rebar set at 25.00 feet), 259.57 feet to a 5/8 inch rebar set; thence S 00°06'30" W, 336.00 feet to a 5/8 inch rebar set; thence S 89°50'07" E (passing through a 5/8 inch rebar set at 234.57 feet), 259.57 feet to the PLACE OF BEGINNING containing 2.002 acres more or less and subject to all highways and other legal easements of record.
