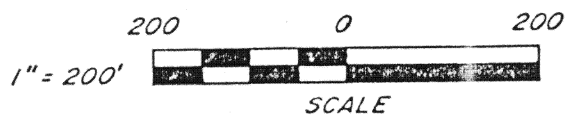
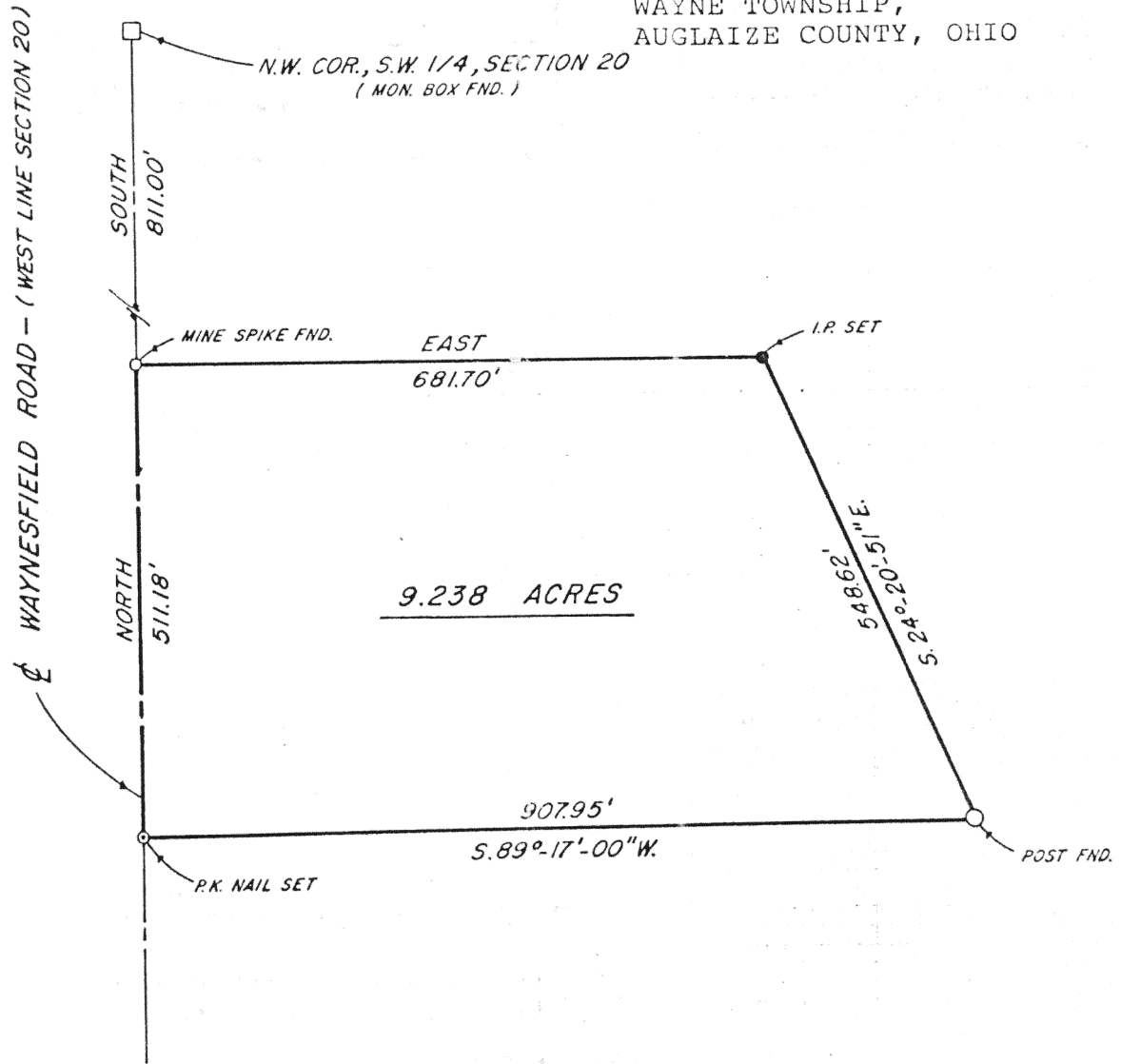




PLAT OF A SURVEY

Being a parcel of land situated in Wayne Township, Auglaize County, Ohio in the southwest $\frac{1}{4}$ of Section 20, Township 5 South, Range 8 East and being more particularly described as follows:

Commencing for reference at a monument box found marking the northwest corner of the southwest $\frac{1}{4}$ of Section 20 and the centerline of Waynesfield Road -

Thence south, on and along the centerline of Waynesfield Road and the west line of Section 20, for a distance of 811.00 feet to a mine spike found marking the point of beginning for the parcel to be conveyed by this instrument -

Thence east, for a distance of 681.70 feet to a 5/8 inch iron pin set -


Thence south $24^{\circ}-20'-51''$ east, for a distance of 548.62 feet to a post found -

Thence south $89^{\circ}-17'-00''$ west, for a distance of 907.95 feet to a P.K. nail set -

Thence north, on and along the centerline of Waynesfield Road and the west line of Section 20, for a distance of 511.18 feet to the point of beginning.

Containing 9.238 acres of land, subject, however to all legal easements and rights-of-way.

Note: All bearings refer to the centerline of Waynesfield Road as being north.
