


SURVEY E

DICKE SURVEY DESCRIPTION

Being a parcel of land situated in Salem Township, Auglaize County, Ohio, in the northeast quarter of Section 31, Township 4 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at an iron pin in a monument box at the northwest corner of the northeast quarter of said Section 31-

Thence, south 84°07'15" east, along the centerline of Hesse Road, a distance of one thousand seven hundred eleven and 15/100 (1711.15) feet to a mine spike. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing south 84°07'15" east, along the last described line, a distance of one hundred fourteen and 39/100 (114.39) feet to a mine spike-

Thence, south $68^{\circ}34'42''$ east, continuing along the centerline of said Hesse Road, a distance of seventy-three and 93/100 (73.93) feet to a 1/2 inch iron bar. Said point being at the intersection of said Hesse Road and Maier Barber Road-

Thence, south $12^{\circ}49^{\circ}40^{\circ}$ east, along the centerline of said Maier Barber Road, a distance of one hundred twenty-two and 37/100 (122.37) feet to a 1/2 inch iron bar-

Thence, south $20^{\circ}58'04''$ east, continuing along the centerline of said Maier Barber Road, a distance of one hundred twenty-six and 27/100 (126.27) feet to a mine spike-

Thence, south $88^{\circ}50'09''$ west, a distance of two hundred fifty-three and 53/100 (253.53) feet to a 5/8 inch iron bar-

Thence, north $00^{\circ}18^{\circ}08^{\circ}$ west, a distance of two hundred eighty-one and 10/100 (281.10) feet to the place of beginning.

Containing 1.284 acres of land more or less.

Subject to all easements and right-of-way of record.
